6. APPLICATION FOR A TWO-YEAR PERMIT TO INSTALL TWO ARTIFICIAL REEFS ON TIDE AND SUBMERGED LANDS OF SANTA BARBARA CHANNEL IN THE VICINITY OF MUGU LAGOON, VENTURA COUNTY; U. S. DEPARTMENT OF THE NAVY, PACIFIC MISSILE RANGE - W.O. 5330, P.R.C. 3351.9.

After consideration of Calendar Item 3 attached, and upon motion duly made and unanimously carried, the following resolution was adopted:

THE EXECUTIVE OFFICER IS AUTHORIZED TO ISSUE TO THE U. S. DEPARTMENT OF THE NAVY, PACIFIC MISSILE RANGE, POINT MUGU, CALIFORNIA, A TWO-YEAR PERMIT TO INSTALL TWO METAL ARTIFICIAL REEFS FOR MARINE SCIENCE STUDIES ON THE FOLLOWING-DESCRIBED LAND:

TWO CIRCULAR PARCELS OF SUBMERGED LAND, 60 FEET IN DIAMETER, IN SANTA BARBARA CHANNEL, VENTURA COUNTY, IN THE VICINITY OF MUGU LAGOON, THE CENTER POINTS OF SAID PARCELS BEING DESCRIBED AS FOLLOWS:

PARCEL NO. 1: 119° 06' 02" W. Longitude
34° 05' 38" N. Latitude

PARCEL NO. 2: 119° 05' 49" W. Longitude
34° 05' 50" N. Latitude

EACH PARCEL CONTAINING 0.065 ACRE.

APPLICATION FOR A TWO-YEAR PERMIT TO INSTALL TWO ARTIFICIAL REEFS ON TIDE AND SUBMERGED LANDS OF SANTA BARBARA CHANNEL IN THE VICINITY OF MUGU LAGOON, VENTURA COUNTY; U. S. DEPARTMENT OF THE NAVY, PACIFIC MISSILE RANGE - W.O. 5330.

The Commander, Pacific Missile Range, U. S. Naval Missile Center, Point Mugu, has applied for a two-year permit to install two artificial reefs of metal construction in the vicinity of Mugu Lagoon, Santa Barbara Channel, as shown on Exhibit "A".

Each reef would consist of two rows of 7' x 7' x 7' steel pontoons, perforated by three-foot holes in two sides of each, and would be secured by a heavy chain running the length of the reef between the two rows and attached at one end to concrete anchoring. Each reef would be 7 feet high, approximately 14 feet wide, and 52 feet long.

The reefs would provide a source of specimens for studies undertaken by the Marine Sciences Division of the Missile Center.

The applicant stated in a letter that the Corps of Engineers had approved the installation.

The consideration is to be the public benefit.

IT IS RECOMMENDED THAT THE COMMISSION AUTHORIZE THE EXECUTIVE OFFICER TO ISSUE TO THE U. S. DEPARTMENT OF THE NAVY, PACIFIC MISSILE RANGE, POINT MUGU, CALIFORNIA, A TWO-YEAR PERMIT TO INSTALL TWO METAL ARTIFICIAL REEFS FOR MARINE SCIENCE STUDIES ON THE FOLLOWING-DESCRIBED LAND:
