2. REQUEST FOR HEARING PURSUANT TO SECTION 126, GOVERNMENT CODE; GENERAL SERVICES ADMINISTRATION - S.W.O. 8143.

The Executive Officer explained the procedure provided by the Legislature whereby, after public hearing and a State Lands Commission determination that it is in the State interest, the Federal Government may acquire civil and criminal jurisdiction and exercise civil and criminal jurisdiction either concurrently with the State, or exclusively under certain circumstances, where it is necessary that the Federal Government be given this authority with respect to operation of Federal installations located within the State of California.
