11. APPLICATION FOR COMMERCIAL MINOR-STRUCTURE PERMIT, TIDE AND SUBMERGED LANDS, SAN JOAQUIN RIVER NEAR ANTIOCH, CONTRA COSTA COUNTY; CROWN ZELLERBACH CORPORATION - W.O. 5959, P.R.C. 3439.1.

After consideration of Calendar Item 23 attached, and upon motion duly made and unanimously carried, the following resolution was adopted:

THE EXECUTIVE OFFICER IS AUTHORIZED TO ISSUE TO CROWN ZELLERBACH CORPORATION A FIVE-YEAR COMMERCIAL MINOR-STRUCTURE PERMIT AT A TOTAL RENTAL OF \$1.00, COVERING THE MAINTENANCE OF FOUR EXISTING DAY-BEACONS ON TIDE AND SUBMERGED LANDS IN THE SAN JOAQUIN RIVER, CONTRA COSTA COUNTY, LOCATED AS FOLLOWS:

APPLICATION FOR COMMERCIAL MINOR-STRUCTURE PERMIT, TIDE AND SUBMERGED LANDS, SAN JOAQUIN RIVER NEAR ANTIOCH, CONTRA COSTA COUNTY; CROWN ZELLERBACH CORPORATION - W.O. 5959.

Crown Zellerbach Corporation has applied for a permit to maintain four existing channel-marker day-beacons on tide and submerged lands in the San Joaquin River approximately 1.5 miles east of Antioch, Contra Costa County, to replace Permit P.R.C. 2704.1, which expires February 5, 1966.

The beacons as installed consist of four black, white-patched piles, and are in compliance with regulations prescribed by the U. S. Coast Guard. A U. S. Army Corps of Engineers navigational permit covering the original installation (as shown on Exhibit "A") was issued on March 5, 1956.

The total rental for a five-year period will be increased from \$50 to \$100, and has been received.

IT IS RECOMMENDED THAT THE COMMISSION AUTHORIZE THE EXECUTIVE OFFICER TO ISSUE TO CROWN ZELLERBACH CORPORATION A FIVE-YEAR COMMERCIAL MINOR-STRUCTURE PERMIT AT A TOTAL RENTAL OF \$100, COVERING THE MAINTENANCE OF FOUR EXISTING DAY-BEACONS ON TIDE AND SUBMERGED LANDS IN THE SAN JOAQUIN RIVER, CONTRA COSTA COUNTY, LOCATED AS FOLLOWS:
