38. SERVICE AGREEMENT, CHAPTER 2018, STATUTES OF 1965, CITY OF BENICIA, COUNTY OF SOLANO - W.O. 5843, GEO.-SOLANO CO., P & C.

After consideration of Calendar Item 29 attached, and upon motion duly made and unanimously carried, the following resolution was adopted:

THE EXECUTIVE OFFICER IS AUTHORIZED TO EXECUTE A SERVICE AGREEMENT WITH THE CITY OF BENICIA, COUNTY OF SOLANO, CALIFORNIA, ON BEHALF OF THE STATE LANDS COMMISSION AS CONTRACTOR, PROVIDING FOR SURVEYING AND PLATTING SERVICES TO BE RENDERED THE CITY PURSUANT TO THE PROVISIONS OF CHAPTER 2018, STATUTES OF 1965, THE PAYMENT TO THE STATE LANDS COMMISSION FOR SAID SERVICES TO BE THE COMMISSION'S ACTUAL COSTS NOT TO EXCEED \$5,500.

SERVICE AGREEMENT, CHAPTER 2018, STATUTES OF 1965, CITY OF BENICIA, COUNTY OF SOLANO - W.O. 5843.

Section 6359 of the Public Resources Code provides that the State Lands Commission, within two years from the effective date of the granting statute, shall survey, monument, and record a plat of any tide and submerged lands granted by the Legislature.

Chapter 2018/65 conveys certain described tide and submerged lands to the City of Benicia; accordingly, the State Lands Commission is required, at the cost of the grantee, to survey, monument, plat, and record a plat of the granted lands.

The work is to be performed on a contract basis and an agreement has been drawn that provides for the rendering of the surveying services by the State Lands Division at its estimated cost of not to exceed \$5,500.

IT IS RECOMMENDED THAT THE EXECUTIVE OFFICER BE AUTHORIZED TO EXECUTE A SERVICE AGREEMENT WITH THE CITY OF BENICIA, COUNTY OF SOLANO, CALIFORNIA, ON BEHALF OF THE STATE LANDS COMMISSION AS CONTRACTOR, PROVIDING FOR SURVEYING AND PLATTING SERVICES TO BE RENDERED THE CITY PURSUANT TO THE PROVISIONS OF CHAPTER 2018, STATUTES OF 1965, THE PAYMENT TO THE STATE LANDS COMMISSION FOR SAID SERVICES TO BE THE COMMISSION'S ACTUAL COSTS NOT TO EXCEED \$5,500.
