APPLICATION TO LEASE A PARCEL OF SUBMERGED LAND IN HUMBOLDT BAY NEAR FAIRHAVEN, HUMBOLDT COUNTY; UNITED STATES PLYWOOD CORPORATION - W.O. 5989.

The United States Plywood Corporation has applied to lease six acres of submerged land in Humboldt Bay adjacent to their upland near Fairhaven, as shown on Exhibits "A" and "B".

The site is being used as a log storage facility for a lumber mill. Also, a small-boat dock is to be relocated within the area. The storage facility consists of driven piles connected by cable.

The U. S. Army Corps of Engineers has approved the installation.

A staff appraisal indicates an annual rental of \$1,787.40 during an initial lease period of five years. The lease will provide for one renewal option of five additional years. A surety bond in the amount of \$1000 will be required.
