APPLICATION FOR PROSPECTING PERMIT, SAN BERNARDINO COUNTY; M. A. LINDNER - W.O. 6114.

An application has been received from M. A. Lindner for a permit to prospect for all minerals other than oil and gas on 41.32 acres of vacant State school land within the NET of Section 16, T. 15 N., R. 10 E., S.B.B.& M., San Bernardino County (see Exhibit "A" attached). The area applied for was formerly prospected by Don C. Hibbert under State Prospecting Permit P.R.C. 3100.2, which permit was assigned on May 27, 1965, to the applicant; however, before the assignment could be completed, P.R.C. 3100.2 terminated on February 20, 1966. Mr. Lindner has now applied to prospect the same area.

Field reconnaissance has shown that the area for which the application has been made cannot be classified as being known to contain commercially valuable mineral deposits.

As required under Section 6890 of the Public Resources Code, the application was referred to the office of the Attorney General, which office has advised that the application complies with the applicable laws and the rules and regulations of the State Lands Commission.

The \$5 statutory filing fee has been paid, and the permit fee of \$41.32 has been deposited by the applicant.
