After consideration of Calendar Item 4 attached, and upon motion duly made and unanimously carried, the following resolution was adopted:

THE EXECUTIVE OFFICER IS AUTHORIZED TO ISSUE TO PHILLIPS PETROLEUM COMPANY A GEOLOGICAL SURVEY PERMIT, CONFORMING TO ALL OPERATING CONDITIONS ESTABLISHED BY THE COMMISSION FOR THE CONDUCT OF GEOLOGICAL SURVEY OPERATIONS, ON THOSE TIDE AND SUBMERGED LANDS UNDER THE JURISDICTION OF THE STATE LANDS COMMISSION IN THE AREA LYING BETWEEN A LINE DRAWN DUE WEST FROM FOINT ARGUELLO, SANTA BARBARA COUNTY, AND THE SOUTHERN BOUNDARY OF THE STATE OF CALIFORNIA.

THE PERMIT IS TO BE ISSUED FOR A SIX-MONTH PERIOD FROM APRIL 28, 1966, THROUGH OCTOBER 27, 1966, AND IS TO SUPERSEDE GEOLOGICAL SURVEY PERMIT P.R.C. 2769.1.

THE PERMITTEE IS TO REIMBURSE THE STATE LANDS DIVISION FOR ANY INSPECTION COSTS.

APPLICATION FOR GEOLOGICAL SURVEY PERMIT; SANTA BARBARA, VENTURA, LOS ANGELES, ORANGE, AND SAN DIEGO COUNTIES; PHILLIPS PETROLEUM COMPANY - W.O. 6078.

An application has been received from Phillips Petroleum Company for a permit to conduct geological survey operations in the California offshore areas lying between a line drawn due West from Point Arguello, Santa Barbara County, and the seaward extension of the boundary between Mexico and the State of California.

Phillips Petroleum Company has been conducting core-emiliar operations under Geological Survey Permit P.R.C. 2769.1, covering the tide and submerged lands under the jurisdiction of the State Lands Commission in the area lying between a line drawn due West from Point Arguello, Santa Barbara County, and the seaward extension of the northwesterly boundary of the City of Newport Beach, Orange County. This permit, originally issued on May 4, 1961, as Geological Survey Permit P.R.C. 2717.1 and redesignated P.R.C. 2769.1 on October 13, 1961, expires on October 12, 1966.

The statutory filing fee has been paid by the applicant.

IT IS RECOMMENDED THAT THE COMMISSION AUTHORIZE THE EXECUTIVE OFFICER TO ISSUE TO PHILLIPS PETROLEUM COMPANY A GEOLOGICAL SURVEY PERMIT, CONFORMING TO ALL OPERATING CONDITIONS ESTABLISHED BY THE COMMISSION FOR THE CONDUCT OF GEOLOGICAL SURVEY OPERATIONS, ON THOSE TIDE AND SUPMERGED LANDS UNDER THE JURISDICTION OF THE STATE LANDS COMMISSION IN THE AREA LYING BETWEEN A LINE DRAWN DUE WEST FROM POINT ARGUELLO, SANTA BARBARA COUNTY, AND THE SOUTHERN BOUNDARY OF THE STATE OF CALIFORNIA.

THE PERMIT IS TO BE ISSUED FOR A SIX-MONTH PERIOD FROM APRIL 28, 1966, THROUGH OCTOBER 27, 1966, AND IS TO SUPERSEDE GEOLOGICAL SURVEY PERMIT P.R.C. 2769.1.

THE PERMITTEE IS TO REIMBURSE THE STATE LANDS DIVISION FOR ANY INSPECTION COSTS.
