The Commission at its meeting of October 9, 1965, designated F. J. Hortig, Executive Officer, as its member on the Equity Committee, with respect to the State's portion of the offshore area of the Wilmington Oil Field at Long Beach, and A. W. Pfeil, Assistant Executive Officer, as alternate member. The Manager and the Assistant Manager for the State Lands Division, Long Beach Unit, were appointed on April 1, 1966.
