6. APPLICATION FOR DREDGING PERMIT, TIDE AND SUBMERGED LANDS, TEAMBOAT SLOUGH AND ALVISO SLOUGH; PARKS AND RECREATION DEPARTMENT, SANTA CLARA COUNTY - W.O. 6236, P.R.C. 3605.9.

After consideration of Calendar Item 23 attached, and upon motion duly made and unanimously carried, the following resolution was adopted:

THE EXECUTIVE OFFICER IS AUTHORIZED TO ISSUE A PERMIT TO THE PARKS AND RECREATION DEPARTMENT OF SANTA CLARA COUNTY TO DREDGE APPROXIMATELY 11,000 CUBIC YARDS OF MATERIAL FROM THE FOLLOWING-DESCRIBED TIDE AND SUBMERGED LANDS:

A PARCEL OF LAND IN THE BED OF STEAMBOAT AND ALVISO SLOUGHS, SITUATE IN THE COUNTY OF SANTA CLARA, STATE OF CALIFORNIA, DESCRIBED AS FOLLOWS:

BEGINNING AT A POINT IN THE SOUTHERLY LINE OF STEAMBOAT SLOUGH, SAID POINT OF BEGINNING BEING ALSO THE EASTERLY TERMINUS OF A COURSE SHOWN AS SOUTH 72° 25' 30" EAST 160.00 FEET ON THAT CERTAIN AMENDED RECORD OF SURVEY RECORDED JULY 18, 1963, IN BOOK 163 OF MAPS AT PAGE 19, SANTA CLARA COUNTY RECORDS; THENCE NORTH 72° 25' 30" WEST 160.00 FEET, SOUTH 71° 26' 30" WEST 55.00 FEET, SOUTH 51° 26' 30" WEST 195.00 FEET, NORTH 58° 34' 30" WEST 125.00 FEET, NORTH 35° 14' 51" EAST 265.53 FEET, SOUTH 33° 25' 26" EAST 112.27 FEET, NORTH 48° 54' 17" EAST 105.63 FEET, SOUTH 62° 30' 43" EAST 280.00 FEET; THENCE SOUTHERLY ACROSS STEAMBOAT SLOUGH SOUTH 14° 09' 20" WEST 82.81 FEET; THENCE NORTH 54° 12' 54" WEST 72.74 FEET TO THE POINT OF BEGINNING; CONTAINING 1.467 ACRES.

THE ISSUANCE OF A PERMIT IS TO BE SUBJECT TO THE APPROVAL OF THE AFFECTED STATE AGENCIES AND TO THE ISSUANCE OF A SAN FRANCISCO BAY CONSERVATION AND DEVELOPMENT COMMISSION PERMIT.

THE CONSIDERATION FOR THE ISSUANCE OF THIS PERMIT IS TO BE THE PUBLIC BENEFIT.

APPLICATION FOR DREDGING PERMIT, TIDE AND SUBMERGED LANDS, STEAMBOAT SLOUGH AND ALVISO SLOUGH; PARKS AND RECREATION DEPARTMENT, SANTA CLARA COUNTY - W.O. 6236.

An application has been received by this Division from the Parks and Recreation Department of Santa Clara County for a permit to dredge approximately 11,000 cubic yards of material from Steamboat Slough and Alviso Slough to provide an entrance channel to the county marina at Alviso. The dredged material will be deposited on state and county land adjacent to the marina. The proposed operations will be financed by a grant from the State Division of Small Craft Harbors.

The applicant has been authorized by the U. S. Corps of Engineers to conduct the proposed dredging operations. The Division of Beaches and Parks has reported verbally that the operation would not affect any of its programs or projects. The Department of Fish and Game has requested that activities deleterious to fish and wildlife be eliminated and that the applicant meet the water quality standards set by the Regional Water Pollution Control Board.

The applicant has applied to the San Francisco Bay Conservation and Development Commission for approval of the proposed dredging. The applicant states that the proposed dredging will be considered at the next meeting of the San Francisco Bay Conservation and Development Commission.

IT IS RECOMMENDED THAT THE COMMISSION AUTHORIZE THE EXECUTIVE OFFICER TO ISSUE A PERMIT TO THE PARKS AND RECREATION DEPARTMENT OF SANTA CLARA COUNTY TO DREDGE APPROXIMATELY 11,000 CUBIC YARDS OF MATERIAL FROM THE FOLLOWING-DESCRIBED TIDE AND SUBMERGED LANDS:

BEGINNING AT A POINT IN THE SOUTHERLY LINE OF STEAMBOAT SLOUGH, SAID POINT OF BEGINNING BEING ALSO THE EASTERLY TERMINUS OF A COURSE SHOWN AS SOUTH 72° 25' 30" EAST 160.00 FEET ON THAT CERTAIN AMENDED RECORD OF SURVEY RECORDED JULY 18, 1963, IN BOOK 163 OF MAPS AT PAGE 19, SANTA CLARA COUNTY RECORDS; THENCE NORTH 72° 25' 30" WEST 160.00 FEET, SOUTH 71° 26' 30" WEST 55.00 FEET, SOUTH 51° 26' 30" WEST 195.00 FEET, NORTH 58° 34' 30" WEST 125.00 FEET, NORTH 35° 14' 51" EAST 265.53 FEET, SOUTH 33° 25' 26" EAST 112.27 FEET, NORTH 48° 54' 17" EAST 105.63 FEET, SOUTH 62° 30' 43" EAST 280.00 FEET; THENCE SOUTHERLY ACROSS STEAMBOAT SLOUGH SOUTH 14° 09' 20" WEST 82.81 FEET; THENCE NORTH 54° 12' 54" WEST 72.74 FEET TO THE POINT OF BEGINNING; CONTAINING 1.467 ACRES.
