8. APPLICATION FOR BRIDGE RIGHT-OF-WAY OVER SUTTER SLOUGH, SACRAMENTO AND YOLO COUNTIES; COUNTIES OF SACRAMENTO AND YOLO - W.O. 6340, P.R.C. 3699.9.

After consideration of Calendar Item 12 attached, and upon motion duly made and unanimously carried, the following resolution was adopted:

THE EXECUTIVE OFFICER IS AUTHORIZED TO ISSUE TO THE COUNTIES OF SACRAMENTO AND YOLO, IN CONSIDERATION OF THE PUBLIC BENEFIT, A 49-YEAR PERMIT FOR THE MAINTENANCE AND RECONSTRUCTION OF AN EXISTING BRIDGE ACROSS THE FOLLOWING-DESCRIBED LAND:

BEGINNING AT THE SOUTHEAST CORNER OF SWAMP LAND SURVEY NO. 385, AS SAID CORNER IS SHOWN ON THE PLAT OF SURVEY OF UPPER PORTION OF STITER ISLAND, FILTD IN THE OFFICE OF THE COUNTY RECORDER OF SACRAMENTO COUNTY ON JUNE 27, 1935, IN BOOK 3 OF SURVEYS, SURVEY NO. 86, SAID CORNER BEING A POINT ON THE LOW WATER LINE ON THE RICHT BANK OF THE SACRAMENTO RIVER; THENCE ALONG SAID LOW WATER LINE NORTH 16° 04' EAST 1769.20 FEET MORE OR LESS TO A POINT AT OR NEAR THE INTERSECTION OF THE LOW WATER LINE OF THE SACRAMENTO RIVER, WITH THE LAST NATURAL MEAN HIGH TIDE LINE OF SUTTER SLOUGH; THENCE ALONG THE LAST NATURAL MEAN HIGH TIDE LINE OF SUTTER SLOUGH NORTH 46° 45' WEST 157.34 FEET MORE OR LESS TO THE TRUE POINT OF BEGINNING; THENCE FROM SAID TRUE POINT OF BEGINNING, ALONG THE CENTERLINE OF A BRIDGE ACROSS SUTTER SLOUGH, NORTH 34° 50' 40" EAST 300.00 FEET MORE OR LESS TO THE NORTHERLY (RIGHT) BANK OF SUTTER SLOUGH; CONTAINING 1.38 ACRES MORE OR LESS.

APPLICATION FOR BRIDGE RIGHT-OF-WAY OVER SUITER SLOUGH, SACRAMENTO AND YOLO COUNTIES; COUNTIES OF SACRAMENTO AND YOLO - W.O. 6340.

The counties of Sacramento and Yolo have applied for a 200- x 300-foot right-of-way over sovereign land in Sutter Slough located approximately one-half mile south of Courtland in Sacramento and Yolo counties (as shown on Exhibit "A").

The right-of-way will cover the existing Sutter Slough Road Bridge, originally constructed in 1938. It is planned to replace the existing timber trestle portions of the bridge with reinforced concrete structures, and to replace existing navigation and protective installations. The main steel truss swing-span will be retained and redecked.

A U. S. Army Corps of Engineers navigational permit has been issued.

The consideration for issuance of a permit will be the public use and benefit.

IT IS RECOMMENDED THAT THE COMMISSION AUTHORIZE THE EXECUTIVE OFFICER TO ISSUE TO THE COUNTIES OF SACRAMENTO AND YOLO, IN CONSIDERATION OF THE PUBLIC BENEFIT, A 49-YEAR PERMIT FOR THE MAINTENANCE AND RECONSTRUCTION OF AN EXISTING BRIDGE ACROSS THE FOLLOWING-DESCRIBED LAND:
