APPROVAL OF SECOND MODIFICATION OF 1967 PLAN OF DEVELOPMENT AND OPERATIONS AND BUDGET, LONG BEACH UNIT, WILMINGTON OIL FIELD, LOS ANGELES COUNTY -W.O. 5200.317.

The City of Long Beach, pursuant to the provisions of Section 5(g), Ch. 138/64, lst E. S., has requested State Lands Commission approval of the Second Modification of the 1967 Plan of Development and Operations and Budget, Long Beach Unit, to provide for the drilling and completion of two water-injection wells.

When the 1967 Plan and Budget for the Long Beach Unit was approved by the Commission at its meeting of October 27, 1966, it was contemplated that two water-injection wells would be drilled from Landsite "X" under the 1966 Plan and Budget. This project was delayed, and therefore this work should be performed under the 1967 Plan and Budget.

This proposed modification will provide for the drilling and equipping of two water-injection wells at a total estimated cost of \$540,000.

One of these injection wells is in compliance with the terms of the "Cooperative Agreement for Water Injection Operations (Long Beach Unit and Fault Block V Ranger Zone Unit)", approved by the Commission at its meeting of January 24, 1967. Surface and bottom-hole locations, drilling schedules, approximate injection rates, and range of injection pressures will be determined as provided for in the approved 1967 Plan and Budget.

The necessary changes in the 1967 Plan and Budget, as set forth in THUMS Approval Request 5-67, are as follows:

- 1. Alter the Plan to provide for two Ranger Zone water-injection wells from the Anaheim Pico Site.
- 2. Increase the following budget categories:

The Division is of the opinion that this modification of the Plan has a sound geologic and engineering basis and is in conformance with the overall develment program for the Ranger Zone, and that the proposed Budget increases represent reasonable estimates of anticipated costs.
