2. DREDGING PERMIT, SEAL SLOUGH AND SAN FRANCISCO BAY, SAN MATEO COUNTY;
CITY OF SAN MATEO - W.O. 6763, P.R.C. 3873.9.

After consideration of Calendar Item 11 attached, and upon motion duly made and unanimously carried, the following resolution was adopted:

THE COMMISSION AUTHORIZES THE ISSUANCE OF A PERMIT TO THE CITY OF SAN MATEO TO DREDGE APPROXIMATELY 50,000 CUBIC YARDS OF MATERIAL, WITHOUT PAYMENT OF ROYALTY, FROM PORTIONS OF SEAL SLOUGH AND SAN FRANCISCO BAY, SAN MATEO COUNTY, IN THE AREA DESCRIBED ON EXHIBIT "A" ATTACHED AND BY REFERENCE MADE A PART HEREOF. THIS PERMIT SHALL BE EFFECTIVE ONLY WHEN A CONCURRENT PERMIT FOR THE SAME AREA SPECIFIED HEREIN IS AUTHORIZED BY THE SAN FRANCISCO BAY CONSERVATION AND DEVELOPMENT COMMISSION.

DREDGING PERMIT

APPLICANT: City of San Mateo

LOCATION: Submerged lands, Seal Slough and San Francisco Bay, San Mateo County

PURPOSE: To provide for the discharge of flood waters from the Marina Lagoon flood-storage reservoir

AMOUNT TO BE DREDGED:
Approximately 50,000 cubic yards

DISPOSITION OF DREDGED MATERIAL:
On shore behind existing levees on the Concar Ranch Properties

CONSIDERATION: The public benefit

COMMENCING AT A POINT ON THE WESTERN BOUNDARY LINE OF MARINER'S ISLAND UNIT NO. 1 SUBDIVISION AS SAID SUBDIVISION IS SHOWN ON THAT CERTAIN MAP ENTITLED "MARINER'S ISLAND UNIT NO. 1, SAN MATEO, SAN MATEO COUNTY, CALIFORNIA," FILED IN THE OFFICE OF THE COUNTY RECORDER OF SAN MATEO COUNTY, MARCH 4, 1966, IN VOLUME 64 OF MAPS AT PAGES 28, 29 AND 30; SAID POINT OF COMMENCEMENT ON SAID BOUNDARY LINE BEING THE SOUTHERLY TERMINUS OF A CURVE HAVING A RADIUS OF 139.99', AN ANGLE OF 28° 19' 52", AN ARC DISTANCE OF 69.22 FEET ALL AS SHOWN ON THE ABOVE-MENTIONED MAP; THENCE FROM SAID POINT OF COMMENCEMENT SOUTHEASTERLY ALONG THE WESTERLY BOUNDARY OF SAID SUBDIVISION SOUTH 42° 11' 30" EAST 354.49 FEET; THENCE LEAVING SAID BOUNDARY IN A SOUTHWESTERLY DIRECTION SOUTH 47° 48' 30" WEST 3.53 FEET; THENCE S. 47° 19' 17" W. 98.70'; THENCE IN A NORTHWESTERLY DIRECTION N. 42° 11' 30" W. 10.02' TO THE TRUE POINT OF BEGINNING AND THE SOUTHERLY TERMINUS OF THE CENTERLINE OF A 100 FOOT WIDE STRIP OF LAND HEREIN DESCRIBED, THENCE NORTHWESTERLY ALONG SAID CENTERLINE THE FOLLOWING COURSES AND DISTANCES: NORTH 42° 11' 30" WEST 92.84 FEET TO A POINT OF TANGENCY WITH A CURVE, CONCAVE SOUTHWESTERLY, HAVING A RADIUS OF 1513 FEET THROUGH WHICH A RADIAL LINE OF SAID CURVE BEARS NORTH 47° 48' 30" EAST; THENCE ALONG SAID CURVE NORTHWESTERLY THROUGH AN ANGLE OF 7° 34' 30", AN ARC DISTANCE OF 200.03 FEET; THENCE NORTH 49° 46' WEST 95.14 FEET TO A POINT OF TANGENCY WITH A CURVE, CONCAVE NORTHEASTERLY, HAVING A RADIUS OF 1208 FEET THROUGH WHICH A RADIAL LINE OF SAID CURVE BEARS SOUTH 40° 14' WEST, THENCE ALONG SAID CURVE NORTHWESTERLY THROUGH AN ANGLE OF 9° 29' 00", AN ARC DISTANCE OF 199.94 FEET; THENCE NORTH 40° 17' WEST 401.95 FEET TO A POINT OF TANGENCY WITH A CURVE, CONCAVE NORTHEASTERLY, HAVING A RADIUS OF 870 FEET THROUGH WHICH A RADIAL LINE OF SAID CURVE BEARS SOUTH 49° 43' WEST, THENCE ALONG SAID CURVE NORTHWESTERLY THROUGH AN ANGLE OF 38° 02' 00", AN ARC DISTANCE OF 577.51 FEET; THENCE NORTH 2° 15' WEST 482.59 FEET TO THE NORTHERLY TERMINUS OF THE CENTERLINE OF SAID 100 FOOT WIDE STRIP OF LAND.

CONTAINING 4.706 ACRES MORE OR LESS.
