EXHIBIT "A"

Legal. Description

A portion of the sovereign lands of the State of California comprising the bed of Tomales Bay, Marin County (near Inverness), adjacent to Seahaven Subdivision No. 1, as per the map of a Subdivision of Lot 11, Block "B", of said Seahaven Subdivision, filed April 3, 1963, in Book 3 of Surveys, at Page 35, Records of Marin County.

Said portion is a strip of land 60.00 feet in width centered about the centerline of the pier shown upon said map filed April 3, 1963, and extending the full length of said pier, together with an additional strip of the same width extending 10.00 feet southeasterly from the course of said centerline shown as "S. 51° 57' E. 17.93 feet" upon said map and such additional strip of land of the same width centered about the centerline of "Easement 'C'", as per said map, as may be required to extend to the Southwesterly boundary of said sovereign lands. Said portion contains 0.22 acre, more or less, as per said map.

EXCEPTING THEREFROM any part thereof lying Southwesterly from said Southwesterly line of said sovereign lands vested in the State of California.
