3. PUBLIC AGENCY PERMIT (RIGHT-OF-WAY), SOVEREIGN LAND, MONTEREY BAY, MONTEREY COUNTY; MARINA COUNTY WATER DISTRICT - W.O. N-0151, P.R.C. 3965.9.

After consideration of Calendar Item 40 attached, and upon motion duly made and unanimously carried, the following resolution was adopted:

THE COMMISSION AUTHORIZES THE ISSUANCE TO THE MARINA COUNTY WATER DISTRICT OF A 49-YEAR PUBLIC AGENCY PERMIT (RIGHT-OF-WAY) FROM JUNE 1, 1968, IN CONSIDERATION OF THE PUBLIC HEALTH AND BENEFIT, FOR INSTALLATION AND PROPER MAINTENANCE OF AN OUTFALL SEWER LINE ON THE LAND DESCRIBED ON EXHIBIT "A" ATTACHED AND BY REFERENCE MADE A PART HEREOF.

## PUBLIC AGENCY PERMIT (RIGHT-OF-WAY)

APPLICANT: Marina County Water District

LOCATION: Sovereign land located within a strip 10 x 2,150 feet long in Monterey Bay at Marina, Monterey County

PROPOSED USE: The installation of an outfall sewer line

TERM: 49 years, from June 1, 1968

CONSIDERATION: No charge (the public health and benefit)

W.O.: N-0151

Lessee: Marina County Water District

A strip of tide and submerged land in Monterey Bay, County of Monterey, State of California, lying 5 feet on each side of the following described centerline:

BEGINNING at a point on the westerly boundary of Lot 97 of Bayside Subdivision, as recorded in the office of the County Recorder of Monterey County, in Volume 2, page 15, of Maps and Ranches, said point bearing N 06° 53' E 40.76 feet, from the most westerly corner of said Lot 97; thence N 86° 30' W 2150 feet, more or less, to the end of the herein described centerline.

EXCEPTING therefrom any portion landward of the mean high tide line.
