

27. GEOLOGICAL SURVEY PERMIT, DEL NORTE COUNTY SOUTH THROUGH SAN DIEGO COUNTY;
SHELL OIL COMPANY - W.O. 7031, P.R.C. 3982.1.

After consideration of Calendar Item 15 attached, and upon motion duly made and unanimously carried, the following resolution was adopted:

THE COMMISSION AUTHORIZES THE ISSUANCE TO SHELL OIL COMPANY OF A GEOLOGICAL SURVEY PERMIT, FROM JUNE 19, 1968, THROUGH DECEMBER 18, 1968, ON TIDE AND SUBMERGED LANDS UNDER THE JURISDICTION OF THE STATE LANDS COMMISSION LYING BETWEEN THE NORTHERN BOUNDARY AND THE SOUTHERN BOUNDARY OF THE STATE OF CALIFORNIA. THE PERMIT IS TO SUPERSEDE GEOLOGICAL SURVEY PERMITS P.R.C. 2768.1 AND P.R.C. 2827.1.

APPLICATION FOR GEOLOGICAL SURVEY PERMIT

APPLICANT: Shell Oil Company

LOCATION: The offshore area lying between the northern boundary and the southern boundary of the State of California

METHOD OF EXPLORATION: Core-hole drilling

TERM: From June 19, 1968, through December 18, 1968

FILING FEE: \$5 submitted

EXPENSES: To be reimbursed by the permittee

OPERATING CONDITIONS: Established by the Commission

OTHER PERTINENT INFORMATION:

Shell Oil Company has been conducting core-hole drilling operations in State waters under two geological permits, P.R.C.s 2768.1 and 2827.1, expiring on July 15, 1968, and is now requesting that these two permits be combined into one permit.
