7. COMMERCIAL MINOR-STRUCTURE PERMIT, SUBMERGED LAND ADJACENT TO SANTA CATALINA ISLAND, LOS ANGELES COUNTY; CONNOLLY PACIFIC CO. - W.O. 7216, P.R.C. 4193.1.

After consideration of Calendar Item 4 attached, and upon motion duly made and unanimously carried, the following resolution was adopted:

THE COMMISSION AUTHORIZES ISSUANCE TO CONNOLLY PACIFIC CO. OF A FIVE-YEAR COMMERCIAL MINOR-STRUCTURE PERMIT BEGINNING JANUARY 4, 1969, IN CONSIDERATION OF ANNUAL RENTAL OF \$200, FOR THE MAINTENANCE OF FOUR MOORING BUOYS ON SUBMERGED LAND ADJACENT TO SANTA CATALINA ISLAND, LOS ANGELES COUNTY, AT THE FOLLOWING LOCATIONS:

COMMERCIAL MINOR-STRUCTURE PERMIT

APPLICANT: Connolly Pacific Co.

LOCATION: Santa Catalina Island.

PROPOSED USE: Mooring buoys for tugs and barges.

TERM: 5 years, from January 4, 1969.

CONSIDERATION: \$200 per annum.

BASIS FOR CONSIDERATION:  
\$50 per site fixed rental for this type of permit.

PREREQUISITE ITEMS:  
U. S. Army Corps of Engineers navigational permit issued.  
Applicant is lessee or permittee of upland.

STATUTORY AND OTHER REFERENCES:  
a. Public Resources Code: Div. 6, Pt. 2, Ch. 1, Secs. 6501-6509.  
b. Administrative Code: Title 2, Div. 3, Secs. 2000-2011.  
c. Commission policy: Minute Item 18 of November 18, 1959.

OTHER PERTINENT INFORMATION:  
The permit will replace Permit P.R.C. 3737.1, which expired January 3, 1969. The buoys are for mooring tugs and barges used to transport quarry material from the Pebbly Beach Quarry about two miles southeasterly of Avalon.
