

9. 49-YEAR PUBLIC AGENCY PERMIT, SUBMERGED LAND IN SAN FRANCISCO BAY, SAN MATEO COUNTY, FOR CONSTRUCTION OF OUTFALL SEWER; CITY OF REDWOOD CITY - W-8545, P.R.C. 4348.9.

After consideration of Calendar Item 15 attached, and upon motion duly made and carried, the following resolution was adopted:

THE COMMISSION AUTHORIZES THE ISSUANCE TO CITY OF REDWOOD CITY OF A 49-YEAR PUBLIC AGENCY PERMIT FROM OCTOBER 1, 1969, IN CONSIDERATION OF THE PUBLIC HEALTH AND BENEFIT, FOR CONSTRUCTION AND OPERATION OF AN OUTFALL SEWER ON THE LAND DESCRIBED ON EXHIBIT "A" ATTACHED AND BY REFERENCE MADE A PART HEREOF. FURTHER, SAID PERMIT AUTHORIZES PERMITTEE'S RIGHT OF ENTRY FOR CONSTRUCTION PURPOSES FROM OCTOBER 1, 1969, TO OCTOBER 1, 1970, OVER A STRIP OF LAND 100 FEET IN WIDTH LYING ADJACENT TO, ON EACH SIDE OF, AND RUNNING PARALLEL WITH THE STRIP OF LAND DESCRIBED ON EXHIBIT "A".

PUBLIC AGENCY PERMIT

APPLICANT: City of Redwood City.

LOCATION: A 20'-x 2633'- strip of submerged land in San Francisco Bay, San Mateo County.

LAND USE: The construction of a 66" outfall sewer to transport treated waste water from Redwood City, San Carlos, and Belmont under terms of a Joint Powers Agreement.

TERM: 49 years, from October 1, 1969.

CONSIDERATION: No charge. The public health and benefit.

PREREQUISITE ITEMS:

A permit has been issued by the Bay Conservation and Development Commission.

U. S. Army Corps of Engineers Permit issued.

Applicant is acquiring property rights in adjacent property.

Federal and State Water Quality Control requirements have been met.

STATUTORY AND OTHER REFERENCES:

- a. Public Resources Code: Div. 6, Pt. 2, Ch. 1, Secs. 6501-6509.
- b. Administrative Code: Title 2, Div. 3, Arts. 1 & 2 as amended effective May 10, 1969.

OTHER PERTINENT INFORMATION:

1. The annual rental value of the site is estimated to be \$4,950.
2. A nonmonetary permit is justified on the premise that free use of State land for treated sewage effluent disposal contributes to State-wide protection of the public health.
3. The applicant also requests a temporary construction easement over a strip of land 100 feet in width lying adjacent to, on each side of, and running parallel with the strip of land described on Exhibit "A".

EXHIBIT "A"

A strip of land 20.00 feet in width in San Francisco Bay, San Mateo County, California, lying equally 10.00 feet on each side of the following described centerline:

BEGINNING at a 3/4" iron pipe from which a 4" x 4" redwood post known as Leslie Salt Co's. Monument 24 bears S. 40° 00' 17" E. 1,112.5 feet, said Monument 24 being an angle point on that certain line agreed to by the State of California and Leslie Salt Co. recorded in Book 5426, page 126, Official Records of San Mateo County, thence from the point of beginning N. 21° 22' 32" E. 7,500 feet to the end of said centerline.
