26. ASSIGNMENT OF DREDGING PERMIT P.R.C. 3690.9, RUSSIAN RIVER, SONOMA COUNTY, FROM UTAH CONSTRUCTION AND MINING COMPANY TO NORTHERN CALIFORNIA AGGREGATES - W-7407.

After consideration of Calendar Item 57 attached, and upon motion duly made and carried, the following resolution was adopted:

THE COMMISSION AUTHORIZES THE APPROVAL OF THE ASSIGNMENT FROM UTAH CONSTRUCTION AND MINING COMPANY, ASSIGNOR, TO NORTHERN CALIFORNIA AGGREGATES, ASSIGNEE, OF STATE DREDGING PERMIT P.R.C. 3690.9, WITH THE ASSIGNEE TO BE BOUND BY THE TERMS AND CONDITIONS OF THE PERMIT TO THE SAME EXTENT AS THE ORIGINAL LESSEE; APPROVAL OF THIS ASSIGNMENT TO BE CONDITIONAL UPON COMMISSION APPROVAL OF ASSIGNMENT OF LEASE P.R.C. 3502.1 FROM UTAH CONSTRUCTION AND MINING COMPANY TO NORTHERN CALIFORNIA AGGREGATES, BEING CONSIDERED THIS DATE.
