4. 15-YEAR PUBLIC AGENCY PERMIT, BED OF LITTLE CONNECTION SLOUGH AT VENICE FERRY, SAN JOAQUIN COUNTY; COUNTY OF SAN JOAQUIN, DEPARTMENT OF PUBLIC WORKS - W.C. 8714, P.R.C. 4460.9.

After consideration of Calendar Item 8 attached, and upon motion duly made and carried, the following resolution was adopted:

PUBLIC AGENCY PERMIT

APPLICANT: County of San Joaquin, Department of Public Works.

LOCATION: Four sign locations (circle of 10' radius) in the bed of Little Connection Slough at Venice Ferry, San Joaquin County.

LAND USE: The installation and maintenance of four warning signs at the Venice Ferry crossing.

TERMS: 15 years, from May 1, 1970.

CONSIDERATION: No charge at this time. The Division is investigating all procedures allowing rent-free permits and leases. This permit reserves the right to set a reasonable rental consistent with policy changes necessitated by the study.

PREREQUISITE ITEMS:
U.S.A. Corps of Engineers Permit issued.

EXHIBIT "A"

Those certain four parcels of tide and submerged land in Little Connection Slough at Venice Ferry, San Joaquin County, California, described as follows:

Parcel 1

That parcel of land immediately beneath a warning sign located 300 feet northwesterly from the easterly Venice Ferry ramp and 380 feet westerly from the easterly bank of Little Connection Slough.

Parcel 2

That parcel of land immediately beneath a warning sign located 300 feet southwesterly from the easterly Venice Ferry ramp and 160 feet westerly from the easterly bank of Little Connection Slough.

Parcel 3

That parcel of land immediately beneath a warning sign located 250 feet southeasterly from the westerly Venice Ferry ramp and 20 feet easterly from the westerly bank of Little Connection Slough.

Parcel 4

That parcel of land immediately beneath a warning sign located 250 feet northeasterly from the westerly Venice Ferry ramp and 170 feet easterly from the westerly bank of Little Connection Slough.
