ASSIGNMENT OF OIL AND GAS LEASE P.R.C. 1340.1

ASSIGNOR: O. R. Howard and Company.  
ASSIGNEE: Signal Oil and Gas Company.  
LOCATION: Huntington Beach, Orange County.  
ACREAGE: A cylindrical area, 24 inches in diameter, extending to total depth.  
TYPE OF LAND: Tide and submerged.

PREREQUISITE ITEMS:

- a. Assignment executed by assignor and assignee.
- b. Subsurface crossing permit executed by assignor and assignee.
- c. Assignee qualified to hold State lease.
- d. Bond submitted by assignee (\$2000).
- e. Statutory filing fee (\$25) paid.
