SEVENTH MODIFICATION OF THE 1970-1971 PLAN OF DEVELOPMENT AND OPERATIONS AND BUDGET, LONG BEACH UNIT, JULY 1, 1970, THROUGH JUNE 30, 1971, WILMINGTON OIL FIELD, LOS ANGELES COUNTY.

The Commission, at its meeting of April 23, 1970, approved the 1970-1971 Plan of Development and Operations and Budget for the Long Beach Unit. Subsequently, the Plan and Budget have been modified six times. The City of Long Beach has submitted the Seventh Modification of this Plan and Budget for Commission approval.

This Seventh Modification is a change in the 1970-1971 Plan providing for the purchase and installation of an additional water-injection pump on Island Alfa, the installation of an existing standby pump on Island Bravo, and the purchase of a new standby pump. The cost of the Island Alfa pump and installation is estimated to be \$125,000, the installation of the pump on Island Bravo, \$28,000, and the purchase of a new standby pump, \$78,000. The necessary funds are to be obtained by transfers from other budget categories within the present budget; thus, no augmentation of funds will be required for this modification.

This Seventh Modification also includes a quarterly review of Long Beach Unit production, water injection, and expenditures through March 31, 1971, pursuant to PART IV-A-2 of the Plan and Budget.

The Division has reviewed the Seventh Modification, as submitted by the City of Long Beach, and finds that the proposed water-injection pump changes are desirable, and that the modification of the Plan of Development is reasonable.

Pursuant to Section 5(g), Chapter 138/1964, lst E.S., the Executive Officer, by letter dated June 8, 1971, approved the Seventh Modification of the 1970-1971 Plan and Budget, subject to ratification by the Commission.
