After consideration of Calendar Item 7 attached, and upon motion duly made and carried, the following resolution was adopted:

THE COMMISSION:

- 1. FINDS THAT, IN ACCORDANCE WITH ENVIRONMENTAL IMPACT REPORT NO. 16 ON FILE IN THE OFFICE OF THE STATE LANDS COMMISSION AND BY REFERENCE MADE A PART HEREOF, A PERMIT AS RECOMMENDED HEREIN WILL NOT HAVE A SIGNIFICANT DETRIMENTAL ENVIRONMENTAL EFFECT.

AUTHORIZES THE ISSUANCE TO PACIFIC GAS AND ELECTRIC COMPANY OF A TEN-YEAR RIGHT-OF-WAY, FROM MAY 1, 1971, IN CONSIDERATION OF ANNUAL RENT IN THE AMOUNT OF \$20.00, WITH THE STATE RESERVING THE RIGHT TO RESET A REASONABLE RENTAL ON EACH FIFTH ANNIVERSARY, FOR THE INSTALLATION AND MAINTENANCE OF A 12 KV DISTRIBUTION LINE ON THE LAND DESCRIBED ON EXHI-BIT "A" ATTACHED.

APPLICANT:

Pacific Gas and Electric Company.

LOCATION:

A 0.28-acre parcel of tide and submerged land in Haas Slough, one mile north of Cache Slough, Solano County.

LAND USE:

An overhead 12 KV distribution line.

TERMS:

10 years, from May 1, 1971.

CONSIDERATION: \$20.00 per annum, with the State reserving the right to review and reset a reasonable rental on each fifth anniversary.

Lessee: Pacific Gas and Electric Company

A strip of submerged land 30 feet wide, in the bed of Haas Slough, lying 15 feet on each side of the following described centerline, situate in Section 2, T. 5 N., R. 2 E., M.D.B.& M., Solano County, more particularly described as follows:
