The 1971-1972 Plan and Budget for the Long Beach Unit, as modified by the Commission in a formal hearing on May 27, 1971, was approved by the Long Beach Unit participants c. June 28, 1971. Subsequently, two modifications have been submitted, in accordance with Section 5(g), Chapter 138, Statutes of 1964, 1st E.S.

This Third Modification provides additional funds for work proposed to be undertaken by the Long Beach Unit Equity Committee, and not anticipated at the time the budget was prepared. Primarily, it will provide \$60,000 for computer mapping. Additional funds are requested by the City of Long Beach for additional salaries and payroll burden for the Field Contractor's personnel used in Equity work. The total budget augmentation proposed is \$104,000.

This modification also provides for a change in Plan to purchase breathing units required by the Occupational Safety and Health Act, at a cost of \$3000. Funds for these units are available by Budget Item transfer and do not require a change in the total budget.
