24. RATIFICATION OF APPROVAL BY THE EXECUTIVE OFFICER OF PUBLIC WORKS PROJECT AUTHORIZATION AND TRANSFER REQUEST FOR THE SUMMERLAND BEACH CLEARANCE PROJECT, SANTA BARBARA COUNTY - W 3399.

During consideration of Calendar Item 22 attached, the Executive Officer read into the record a letter dated November 29, 1972, from State Senator Robert J. Lagomarsino, asking that the Commission be advised that he strongly supported its approval of this item and would appreciate favorable action thereon.

Upon motion duly made and carried, the following resolution was adopted:

THE COMMISSION APPROVES THE PUBLIC WORKS PROJECT AUTHORIZATION AND TRANSFER REQUEST FOR THE SUMMERLAND BEACH CLEARANCE PROJECT IN THE AMOUNT OF \$50,000 AND RATIFIES THE EXECUTION OF THE TRANSFER DOCUMENT ON OCTOBER 30, 1972, BY THE EXECUTIVE OFFICER.

RATIFY APPROVAL BY THE EXECUTIVE OFFICER OF PUBLIC WORKS PROJECT  
AUTHORIZATION AND TRANSFER REQUEST FOR THE SUMMERLAND BEACH  
CLEARANCE PROJECT, SANTA BARBARA COUNTY

The Legislature in 1966 appropriated the sum of \$53,400 to the State Lands Division for the removal of beach and underwater obstructions from State-owned tide and submerged lands near Summerland, Santa Barbara County.

Under the 1966 appropriation, 62 well casings were cut off and removed. There are 28 casings remaining, and for their removal, an additional sum of \$50,000 was appropriated (Chapter 648, Statutes of 1969).

As a result of Division priorities and insufficient staff, the project has not been completed. Further, because of administrative regulation requiring encumbrance of the current appropriation by November 10, 1972, it was requested that the \$50,000 be transferred to the Office of Architecture and Construction. Under this procedure the availability of the appropriation will continue, and the project will be undertaken by the Office of Architecture and Construction. Therefore, in order to effect the transfer before November 10, 1972, the Executive Officer signed the transfer document on October 30, 1972.

IT IS RECOMMENDED THAT THE COMMISSION APPROVE THE PUBLIC WORKS PROJECT AUTHORIZATION AND TRANSFER REQUEST FOR THE SUMMERLAND BEACH CLEARANCE PROJECT IN THE AMOUNT OF \$50,000 AND RATIFY THE EXECUTION OF THE TRANSFER DOCUMENT ON OCTOBER 30, 1972, BY THE EXECUTIVE OFFICER.
