North Humboldt Bay, Humboldt County.

LAND USE:

Maintenance of an existing barge-loading dock.

TERMS OF ORIGINAL LEASE:

Initial period: 15 years, from August 1, 1971.

Renewal options: Two additional periods of 10 years each.

Surety bond:

\$50,000.

Public liability insurance:

\$500,000/\$1,000,000 for personal injury

and \$250,000 for property damage.

CONSIDERATION: \$13,500 per annum with State reserving the right to review and reset a reasonable rental on each fifth anniversary.

An executed assignment has accordingly been received with request for Commission approval.
