ASSIGNMENT OF LEASE PRC 4158.1

ASSIGNOR: Oliver Investment Company, a Nevada Corporation.

ASSIGNEE: Davis Financial Corporation.

LOCATION: A 0.133-acre parcel of submerged land in Lake Tahoe near Sunnyside, Placer County.

LAND USE: The maintenance of an existing pier.

TERMS OF LEASE:

Initial Period: 49 years, December 1, 1968.

Surety Bond: \$1,000.

CONSIDERATION: \$154.67 per annum during the first five years, with State reserving the right to review and reset a reasonable rental on each fifth anniversary.

STATUTORY AND OTHER REFERENCES:

a. Public Resources Code: Division 6, Parts 1 and 2.
b. Administrative Code: Title 2, Division 3, Articles 1 and 2.

OTHER PERTINENT INFORMATION:
