17. APPROVAL OF REDRILLING WELLS "STATE 392" S-76, "STATE 392" S-94, "STATE 392" S-138, AND "STATE 425" 525; HUNTINGTON BEACH FIELD, ORANGE COUNTY; SIGNAL OIL AND GAS COMPANY - PRC 425.1, E 392.1.

After consideration of Calendar Item 16 attached, and upon motion duly made and carried, the following resolution was adopted:

THE COMMISSION AUTHORIZES THE APPROVAL OF REDRILLING AND COMPLETING WELLS "STATE 392" S-76, "STATE 392" S-94, "STATE 392" S-138, AND "STATE 425" 525, IN ACCORDANCE WITH THE TERMS AND CONDITIONS OF AGREEMENT FOR EASEMENT 392.1 AND STATE OIL AND GAS LEASE PRC 425.1, RESPECTIVELY, SIGNAL OIL AND GAS COMPANY, LESSEE, AND THE RULES AND REGULATIONS OF THE COMMISSION.

"STATE 392" S-76, "STATE 392" S-94
"STATE 392" S-138, AND "STATE 425" 525

LEASES: E 392.1 and PRC 425.1.
LESSEE: Signal Oil and Gas Company.
COUNTY: Orange.
AREA: Huntington Beach Field.

PERTINENT INFORMATION:

Signal has initiated a full-scale waterflood operation. Production performance clearly indicates that the program has been successful, resulting in an economic advantage to the State. In order to maintain a coordinated and uninterrupted secondary recovery development program, Signal has submitted an application to redrill "State 392" S-76 as a producing well, and to redrill as injection wells "State 392" S-94, "State 392" S-138 and "State 425" 525. The proposed redrills are part of the plan for secondary recovery operations approved by the Commission for E 392.1 on November 6, 1963 (Minute Item 21, page 9362) and for PRC 425.1 on July 2, 1965 (Minute Item 21, page 11,383).

The proposed completion intervals in these wells will provide the best development spacing for optimum flood response. The surface locations of these wells are on the uplands.

The proposed redrilling and completion programs have been reviewed by the Division and determined to be in accordance with good engineering practices and the rules and regulations of the Commission. The Division of Oil and Gas has approved the redrilling of these wells. The proposed wells are part of the plan of development exempted from permit requirements by the South Coast Regional Commission.
