REQUEST FOR APPROVAL OF MODIFICATION OF CALIFORNIA ADMINISTRATIVE CODE, TITLE 2, DIVISION 3, ARTICLE 3, SECTION 2110

The American Petroleum Institute and other segments of the oil industry, have recommended that temperature corrections of all measured volumes to 60° F. be according to Table 6 and Table 24 of the Petroleum Measurement Tables (ASTM Designation D-1250), API Standard 2540, IP Designation 200). This will apply to all crude oil, raw material and finished product volumes including runs from leases as well as all receipts and deliveries between carriers and shippers. The effect of this change will be to improve the accuracy of volume temperature corrections.

In accordance with this revised procedure for crude oil measurements, Section 2110 of the California Administrative Code should be modified as follows:

The volume of oil run shall be the volume corrected to 60 degrees F. according to the schedule "Abridged-Velume-Correction-Table-for Petroleum-Oil"-approved-by-the-American-Petroleum-Institute "American Petroleum Institute Standard 2540, Table 6 (ASTM D-1250 Tables 6 and 24)".
