After consideration of Calendar Item 8 attached, and upon motion duly made and calried, the following resolution was adopted:

THE COMMISSION:

- 1. DETERMINES THAT AN ENVIRONMENTAL IMPACT REPORT HAS NOT BEEN PREPARED FOR THIS ACTIVITY BECAUSE IT IS CATEGORICALLY EXEMPT UNDER THE PROVISIONS OF PRC SECTION 21084; 14 CAL. ADM. CODE SECTIONS 151.00, ET SEQ.; AND 2 CAL. ADM. CODE SECTION 2910(a).
- 2. AUTHORIZES THE ISSUANCE TO JAMES R. MARTIN AND JEAN MARTIN OF A 5-YEAR COMMERCIAL LEASE FROM AUGUST 7, 1973, ALONG WITH THE LESSEES' OPTION TO RENEW SAID LEASE FOR 1 ADDITIONAL PERIOD OF 5 YEARS, UPON SUCH PEASON-ABLE TERMS AND CONDITIONS AS THE STATE MAY IMPOSE, AND CONDITIONED UPON THE LESSEES! 2. The applicants have obtained a lease with a five-year renewal option on the upland, said lease expiring five years from the date of close of escrow from the applicants' purchase of the marina. Any renewal of a commercial lease by the Commission would be conditioned upon the applicants' successful renewal of the upland lease.

EXHIBIT "A"

A parcel of tide and submerged land located in the bed of the Sacramento River, Sacramento County, State of California, said parcel being more particularly described as follows:

COMMENCING at the southwest corner of Swamp and Overflowed Lands Survey No. 245, patented November 10, 1910, from the State of California to Claud Francis Lods, recorded in Book 12 of patents, page 9, Sacramento County, in Section 10, T 7 N, R 4 E, MDM, and running thence North 104.2 feet to a point on the Sacramento River levee; thence N 88° 02' E, 152.5 feet; thence South 80 feet to the TRUE POINT OF BEGINNING; thence East 533.4 feet to a point on the southerly extension of the east line of Parcel No. 2 as described in that deed from Eileen Dutra to Anthony and Eileen Dutra, recorded in Volume 1990, page 111, records of said County; thence South 90 feet; thence westerly parallel to the line of mean high water 533.4 feet; thence North 90 feet to the true point of beginning.

EXCEPTING THEREFROM all portions lying landward of the ordinary high water line.
