25. BOUNDARY DESCRIPTION OF THE PROPOSED ANNEXATION OF TIDE AND SUBMERGED LANDS TO THE OXNARD HARBOR DISTRICT, VENTURA COUNTY - W 2400.101.

APPROVAL OF A BOUNDARY DESCRIPTION OF THE PROPOSED ANNEXATION OF
TIDE AND SUBMERGED LANDS TO THE OXNARD HARBOR DISTRICT, VENTURA COUNTY

The proposed annexation to the Oxnard Harbor District includes submerged lands within the Pacific Ocean and, accordingly, pursuant to Section 3501⁴ of the Government Code, the State Lands Commission is required to approve or disapprove a description of the boundaries of the annexation in respect to the included State-owned tide and submerged lands.

The description of the boundaries has been reviewed by the Division and has been found to comply with Section 3501⁴ of the Government Code.

W 2400.101

That portion of the County of Ventura, as said County is described in Section 25156 of the State of California Government Code, more particularly described as follows:

BEGINNING at the intersection of the northerly line of Rancho El Rio de Santa Clara O'La Colonia, as partitioned by order of District Court, 1st Judicial District, California, filed in the office of the County Clerk of said County in that certain action entitled "Thomas A. Scott, et al., Pliffs. vs. Rafael Gonzales, et al., Defts." With the shore of the Pacific Ocean, thence along said shore:

1. Southeasterly to a point in the southeasterly line of Rancho Guadaluca; thence
2. Southwesterly three miles along the southeasterly prolongation of said Rancho line, thence
3. Northwesterly, along the southwesterly line of said Ventura County to its point of intersection with the third course of annexation No. 61-10A (Southern California Edison) to the City of Oxnard as filed with the Secretary of State on January 2, 1962; thence along said third course
4. N 79° 45' E to the point of beginning.

END OF DESCRIPTION
