14. AMENDMENT OF INDUSTRIAL LEASE PRC 3454.1, TIDE AND SUBMERGED LAND IN-SUISUN BAY, CONTRA COSTA COUNTY; PHILLIPS PETROLEUM COMPANY - W 5204, PRC 3454.1.

After consideration of Calendar Item 13 attached, and upon motion duly made and carried, the following resolution was adopted:

THE COMMISSION AUTHORIZES THE ISSUANCE TO PHILLIPS PETROLEUM COMPANY OF AN AMENDMENT TO LEASE PRC 3454.1, COVERING THE SITE OF PETROLEUM WHARF "AVON" IN SUISUN BAY, CONTRA COSTA COUNTY; TO PROVIDE FOR FIRM ANNUAL RENTAL OF \$8,069.78 DURING THE PERIOD JULY 26, 1964, TO JULY 25, 1979; PROVIDED THAT ALL OTHER TERMS AND CONDITIONS OF LEASE PRC 3454.1 SHALL REMAIN IN FULL FORCE AND EFFECT.

AMENDMENT OF INDUSTRIAL LEASE PRC 3454-1

APPLICANT: Phillips Petroleum Company.

AREA, TYPE LAND AND LOCATION:

10.635 acres of tide and submerged land in Suisun Bay, Contra Costa County.

CRK 5204

LAND USE: "Avon" wharf for transporting petroleum products.

TERMS OF ORIGINAL LEASE:

Initial period: 15 years, from July 26, 1964.

Renewal options: 3 additional periods of 10 years each.

Surety bond: \$50,000.

CONSIDERATION: A tentative annual rental of \$385 is now in effect. This amendment sets firm annual rental of \$8,069.78.

BASIS FOR CONSIDERATION:

(Firm rental only) 6% of the appraised land value.

STATUTORY AND OTHER REFERENCES:

a. Public Resources Code: Div. 6, Parts 1 and 2. b. Administrative Code: Title 2, Div. 3, Arts. 1, 2 and 10.

OTHER PERTINENT INFORMATION:

- 1. An environmental impact report is not required. The action involved herein is not a project.
- 2. When this lease was issued, there was disagreement between the parties as to the method for determining rental for petroleum wharf sites. The controversy continued until recently when Phillips agreed to accept the State's rental terms retroactive to July 26, 1964. The company has accordingly executed an amending document and remitted \$76,847.80 to cover additional rental now due.
