## MINUTE ITEM

13. MAINTENANCE DREDGING PERMIT, TIDE AND SUBMERGED LAND IN GLORIETTA BAY, SAN DIEGO COUNTY; GLORIETTA BAY MARINA - W 9733, PRC 4940.1.

After consideration of Calendar Item 11 attached, and upon motion duly made and carried, the following resolution was adopted:

THE COMMISSION:

- 1. DETERMINES THAT AN ENVIRONMENTAL IMPACT REPORT HAS NOT BEEN PREPARED FOR THIS ACTIVITY AS SUCH REPORT IS NOT REQUIRED UNDER THE PROVISIONS OF PRC 21085, 2 CAL. ADM. CODE 15100, AND 2 CAL. ADM. CODE 2910.
- 2. AUTHORIZES THE ISSUANCE OF A PERMIT TO GLORIETTA BAY MARINA TO DREDGE 200 CUBIC YARDS OF MATERIAL FROM AN AREA OF TIDELANDS AS DESCRIBED IN EXHIBIT "A" ATTACHED AND BY REFERENCE MADE A PART HEREOF AT A ROYALTY RATE OF \$0.10 PER CUBIC YARD, FOR THE MAINTENANCE OF NAVIGABILITY IN SAID MARINA, SUBJECT TO THE ISSUANCE OF PERMISSION FOR THE PROJECT BY THE U. S. ARMY CORPS OF ENGINEERS; SUCH PERMIT TO BE EFFECTIVE JULY 25, 1974, TO DECEMBER 31, 1974, UNLESS SOONER TERMINATED BY THE DIVISION.

#### MAINTENANCE DREDGING PERMIT

APPLICANT:

Glorietta Bay Marina.

PROJECT: Dredge 200 cubic yards of accumulated material from west corner of docking area of Glorietta Bay Marina in San Diego Bay, City of Coronado (dredge area described in attached Exhibit "A"); all dredge material to be disposed of at an inland disposal site.

PURPOSE: Maintenance of navigability.

OWNERSHIP: State land granted to San Diego Unified Port District with minerals reserved to the State.

CONSIDERATION: \$0.10 per cubic yard royalty.

OTHER PERTINENT DATA:

1. Approvals for the work have been issued by:

a. State Water Quality Control Board.

b. City of Coronado.

- c. California State Coastal Zone Conservation Commission.
- 2. Applicant has requested approval from the U.S. Army Corps of Engineers (PN No. 74-25 issued April 3, 1974).
- 3. The proposed maintenance dredging permit will be made conditional to the issuance of the required U. S. Army Corps of Engineers permit.
- 4. Under the provisions of PRC 21085, and 2 Cal. Adm. Code 15100 and 2 Cal. Adm. Code 2910 (Categorical Exemptions), an environmental impact report is not required for the project.
