3. AMENDMENT OF PUBLIC AGENCY PERMIT PRC 3969, SOVEREIGN LAND IN THE BED OF THE COLORADO RIVER, IMPERIAL COUNTY: STATE DEPARTMENT OF TRANSPORTATION - WP 3969, PRC 3969.

After consideration of Calendar Item 1 attached, and upon motion duly made and carried, the following resolution was adopted:

THE COMMISSION:

1. DETERMINES THAT AN ENVIRONMENTAL IMPACT STATEMENT HAS BEEN PREPARED FOR THIS PROJECT AND CERTIFIED BY THE ARIZONA HIGHWAY DEPARTMENT ON JUNE 29, 1972, FOR THE FEDERAL HIGHWAY ADMINISTRATION.
2. CERTIFIES THAT THE INFORMATION CONTAINED IN THE ENVIRONMENTAL IMPACT STATEMENT BY THE ARIZONA HIGHWAY DEPARTMENT HAS BEEN REVIEWED AND CONSIDERED BY THE COMMISSION.
3. DETERMINES THAT THE PROJECT WILL NOT HAVE A SIGNIFICANT EFFECT ON THE ENVIRONMENT.
4. AUTHORIZES THE ISSUANCE TO THE STATE DEPARTMENT OF TRANSPORTATION, PURSUANT TO SECTION 101.5 OF THE STREETS AND HIGHWAYS CODE, OF AN AMENDMENT TO PUBLIC AGENCY PERMIT PRC 3969 FOR AN INDEFINITE PERIOD FROM MAY 1, 1975; AND THE APPROVAL OF THE APPROPRIATE PLAT AUTHORIZING THE MAINTENANCE OF A HIGHWAY AND BRIDGE CROSSING STATE SOVEREIGN LAND: AS DESCRIBED ON DEPARTMENT OF TRANSPORTATION MAP NO. 75568.2 ON FILE IN THE OFFICE OF THE STATE LANDS COMMISSION AND BY REFERENCE MADE A PART HEREOF.

APPLICANT: State Department of Transportation  
1120 N Street  
Sacramento, California 95814

AREA, TYPE LAND AND LOCATION:  
Approximately 0.93 acre of sovereign land in  
the bed of the Colorado River, Imperial County.

LAND USE: A bridge serving State Route 8.

TERMS OF ORIGINAL LEASE:  
Period: Indefinite period, from July 12, 1968.

CONSIDERATION: As set forth in Section 101.5, Streets and  
Highways Code.

TERMS OF AMENDMENT:  
Period: Indefinite period, from May 1, 1975.

CONSIDERATION: As set forth in Section 101.5, Streets and  
Highways Code.

BASIS FOR CONSIDERATION:  
Chapter 1052, Statutes of 1969.

PREREQUISITE TERMS:  
Applicant is owner of upland.

STATUTORY AND OTHER REFERENCES:  
a. Public Resources Code: Div. 6, Parts 1 & 2.  
b. Administrative Code: Title 2, Div. 3,  
Arts. 1, 2 & 10.  
c. Streets and Highways  
Code: Section 101.5.

OTHER PERTINENT INFORMATION:  
1. On July 12, 1968, the State Lands  
Commission reserved for highway purposes a  
portion of the bed of the Colorado River for  
construction of a bridge serving State Route 8.  
2. During the processing of environmental docu-  
ments by the Arizona Highway Department,  
objections were raised regarding the loca-  
tion of the terminus of the bridge on the  
Arizona side. In order to mitigate the  
environmental objections, the Arizona terminus  
was moved, thus changing the alignment of  
the bridge across State lands in California. 355

3. The environmental impact statement received wide circulation through the various State agencies within California and all comments received were answered satisfactorily in the final impact statement.
4. The final environmental statement prepared by the Arizona Highway Department has been reviewed by the State Lands Division and found to be in accordance with the State EIR Guidelines and the Commission's regulations.
5. The estimated annual rental value is \$100.

AUTHORIZE THE ISSUANCE TO THE STATE DEPARTMENT OF TRANSPORTATION, PURSUANT TO SECTION 101.5 OF THE STREETS AND HIGHWAYS CODE, OF AN AMENDMENT TO PUBLIC AGENCY PERMIT PRC 3960 FOR AN INDEFINITE PERIOD FROM MAY 1, 1975; AND THE APPROVAL OF THE APPROPRIATE PLAT AUTHORIZING THE MAINTENANCE OF A HIGHWAY AND BRIDGE CROSSING STATE SOVEREIGN LAND; AS DESCRIBED ON DEPARTMENT OF TRANSPORTATION MAP NO. 75568.2 ON FILE IN THE OFFICE OF THE STATE LANDS COMMISSION AND BY REFERENCE MADE A PART HEREOF.
