30. SERVICE CONTRACT; WOODWARD-CLYDE, CONSULTANTS - W 9732.

After consideration of Calendar Item 28 attached, and upon motion duly made and carried, the following resolution was adopted:

THE COMMISSION RATIFIES THE STAFF'S COMPLIANCE WITH THE COMMISSION'S DIRECTIVE OF JANUARY 14, 1975, AND AUTHORIZES THE EXECUTIVE OFFICER TO EXECUTE A CONTRACT WITH WOODWARD-CLYDE, CONSULTANTS TO PREPARE AN ENVIRONMENTAL IMPACT REPORT FOR THE PROPOSED RESUMPTION OF DRILLING BY STANDARD OIL COMPANY OF CALIFORNIA IN THE SANTA BARBARA CHANNEL, AT A COST NOT TO EXCEED \$42,000; SAID CONTRACT IS ON FILE WITH THE STATE LANDS DIVISION AND BY REFERENCE MADE A PART HEREOF.

PURPOSE: In accordance with the Commission's directive of January 14, 1975, the staff solicited proposals for the preparation of an Environmental Impact Report for the proposed resumption of drilling by Standard Oil Company of California in the Santa Barbara Channel. Four bids were received which are listed as follows:

Fugro, Inc.
Henningson, Durham and Richardson
Dames and Moore
Woodward-Clyde, Consultants

An analysis of the bids received shows that Woodward-Clyde, Consultants is the lowest acceptable bidder.

CONTRACT TERMS: Time: A review draft of the report is to be delivered to the State Lands Division within eleven weeks of the execution date of the contract.

Cost: Total allowable costs for services to be rendered not to exceed \$42,000.
