35. CUTTING BOUNDARY AGREEMENT, SCHOOL LAND IN SHASTA COUNTY; DEPARTMENT OF AGRICULTURE, FOREST SERVICE; SOUTHERN PACIFIC LAND COMPANY OF SAN FRANCISCO, CALIFORNIA; U. S. PLYWOOD-CHAMPION INTERNATIONAL; AND YUBA RIVER LAND COMPANY - W 20739, PRC 5036.

After consideration of Calendar Item 33 attached, and upon motion duly made and carried, the following resolution was adopted:

THE COMMISSION:

1. DETERMINES THAT AN ENVIRONMENTAL IMPACT REPORT HAS NOT BEEN PREPARED FOR THIS ACTIVITY AS SUCH REPORT IS NOT REQUIRED UNDER THE PROVISIONS OF PRC 21065 AND 14 CAL. ADM. CODE 15037.
2. AUTHORIZES THE EXECUTION OF A CUTTING BOUNDARY AGREEMENT IN THE FORM OF EXHIBIT "B" ON FILE IN THE OFFICE OF THE STATE LANDS COMMISSION AND BY REFERENCE MADE A PART HEREOF, BETWEEN THE STATE OF CALIFORNIA, STATE LANDS COMMISSION; AND THE UNITED STATES DEPARTMENT OF AGRICULTURE, FOREST SERVICE; SOUTHERN PACIFIC LAND COMPANY OF SAN FRANCISCO, CALIFORNIA; U. S. PLYWOOD-CHAMPION INTERNATIONAL; AND YUBA RIVER LAND COMPANY.

CUTTING BOUNDARY AGREEMENT

On February 10, 1975, the State Lands Division received a proposed Cutting Boundary Agreement from the U. S. Department of Agriculture, Forest Service, Shasta-Trinity National Forest, Weaverville, California.

The agreement proposes to establish, for timber cutting purposes only, the interior section corners of T 35 N, R 6 W, MDM. State-owned lands under the jurisdiction of the State Lands Commission within said township consists of the N-1/2 of Section 36, containing 320 acres, more or less. The proposed agreement has the effect of identifying for timber cutting purposes, the north and west lines of the N-1/2 of Section 36, T 35 N, R 6 W, MDM.

The U. S. Department of Agriculture, acting by and through the Forest Supervisor, Shasta-Trinity National Forest; Southern Pacific Land Company of San Francisco; U. S. Plywood-Champion International; and Yuba River Lumber Company, desire to harvest timber on lands situated within T 35 N, R 6 W, MDM, adjacent to the State lands. The official Public Land Survey corners required to determine the location of the boundaries were not recovered and cannot be reset without an unduly prohibitive expenditure of time and funds. As a means of expediency, cutting boundary monuments have been set on the ground by both the United States Department of Agriculture, Forest Service and Southern Pacific Land Company of San Francisco, California.

The proposed Cutting Boundary Agreement has been reviewed and approved by the Division.

A copy of the proposed agreement is on file in the office of the State Lands Division and by reference made a part hereof.

Pursuant to Public Resources Code Section 6370.1, the N-1/2 of Section 36, T 35 N, R 6 W, MDM, is not situated on State land identified as environmentally significant.
