11. USE PERMIT; SUBMERGED LAND IN LAKE TAHOE, EL DORADO COUNTY; TROMBETTA DISTRIBUTORS, A CALIFORNIA CORPORATION; WP 4264; PRC 4264.

After consideration of Calendar Item 9 attached, and upon motion duly made and carried, the following resolution was adopted:

THE COMMISSION:

1. DETERMINES THAT AN ENVIRONMENTAL IMPACT REPORT HAS NOT BEEN PREPARED FOR THIS ACTIVITY AS SUCH REPORT IS NOT REQUIRED UNDER THE PROVISIONS OF PRC 21085, 14 CAL. ADM. CODE 15100 ET SEQ., AND 2 CAL. ADM. CODE 2907.
2. AUTHORIZES THE ISSUANCE TO TROMBETTA DISTRIBUTORS, A CALIFORNIA CORPORATION, OF A FIVE-YEAR USE PERMIT FROM MARCH 1, 1974 IN CONSIDERATION OF ANNUAL RENT IN THE AMOUNT OF \$75; THE PROVISION OF A \$2,000 SURETY BOND, FOR MAINTENANCE OF AN EXISTING PIER, ON THE LAND DESCRIBED ON EXHIBIT "A" ATTACHED AND BY REFERENCE MADE A PART HEREOF.
