ASSIGNMENT OF INTEREST IN OIL AND

LEASES: PRC 163, E 392, PRC 425 and PRC 426.

ASSIGNOR: Estate of Maude H. Clock.

ASSIGNEES: Henry H. Clock, Philip T. Clock, Ralph Clock,
and Edwin H. Clock.

LOCATION: Huntington Beach, Orange County.

PREREQUISITE TERMS:

- a. Court Order approving distribution of Maude H. Clock estate.
- b. Assignees qualified to hold State leases.
- c. Statutory filing fee of \$100 for four assignments paid.

OTHER PERTINENT INFORMATION:

Burmah Oil and Gas Company has requested the approval of the assignments of all interest of Maude H. Clock (deceased) from her own nonoperating interest of 0.20941% in each lease to Henry H. Clock, Phillip T. Clock, Ralph Clock, and Edwin H. Clock. Burmah Oil and Gas Company is the present operator and has controlling interest (92%) in the lease. Burmah Oil and Gas Company has submitted Court Order No. SO P-15858 Approving Report, Petition for Partial Distribution Prior to Final Settlement of the estate of Maude H. Clock. Distribution of the Estate by that Order assigns various interest to the following:

- a. An undivided one-fourth interest to Henry H. Clock.
- b. An undivided one-fourth interest to Philip T. Clock.
- c. An undivided one-fourth interest to Ralph Clock.
- d. An undivided one-fourth interest to Henry H. Clock in trust for Edwin H. Clock (since said trust terminated on September 24, 1974, the undivided one-fourth interest is now vested entirely to Edwin H. Clock).

The leases provide that the leases may not be assigned, transferred or sublet except with the written consent of the State.
