AREA, TYPE LAND AND LOCATION: 1.102 acre parcel of tide and submerged land in the Sacrament River, Mile 124.5, near Grimes, Colusa County.

Commercial Marina, LAND USE:

TERM OF ORIGINAL LEASE:

Initial period: 11 years from May 26, 1965.

\$1,000. Surety bond: .

\$150 per annum with 5-year Consideration review.

TERMS OF REPLACEMENT LEASE:

15 years from May 26, 1976. Initial period:

Renewal options: 3 successive periods of 10 years each.

BASIS FOR CONSIDERATION:

\$225 minimum rental for this type of lease or permit.

OTHER PERTINENT INFORMATION:

- 1. An Environmental Impact Report is not required. This transaction is within the purview of 2 Cal. Adm. Code 2907(a) which exempts an existing structure or facility that is in an acceptable state of repair and there is no evidence of record to show injury to adjacent property, shoreline erosion, or other types of environmental degradation.
- 2. This project is situated on State land identified as possessing significant environmental values pursuant to Public Resources Code 6370.1., and is classified in a use category, Chase B, which authorizes Limited Use.

Stati review indicates that there will be no significant effect upon the identified environmental values. This is an existing facility for which no adverse commonts have been received.


