to be in the State's best interest.

OTHER PERTINENT INFORMATION:

- 1. An Environmental Impact Report is not required. This project is categorically exempt from CEQA because actions taken by regulatory agencies as authorized by State law to assure the maintenance, restoration, or enhancement of a natural resource where the regulatory process involves procedures for protection of the environment, for these same reasons this project is consistent with the Commission's Coastal Zone Regulations.
- 2. This project is situated on State land identified as possessing significant environmental values pursuant to Public

Resources Code 6370.1, and is classified in a use category, Class C which authorizes Multiple Use.
