- 4. This project is situated on State land identified as possessing significant environmental values pursuant to Public Resources Code 6307.1, and is classified in a use category, Class A which authorizes Restricted Use.

Staff has coordinated this project with those agencies and organizations who nominated the site as containing significant environmental values. They nave found this project to be compatible with their nomination.

5. Applicant has applied for permits from the U.S. Army Corps of Engineers and the State Reclamation Board. Permit has been issued by the State Department of Fish and Game.
