A 12.97 acre parcel of school lands in the west half of Section 16, T19S, R41E, M.D.M., in Inyo County, approximately 3airline miles northeasterly of Darwin.

LAND USE:

Operation and maintenance of existing utility lines consisting of a 4" water pipeline, an electric power line and a telephone line.

CONSIDERATION: \$359.60 per annum with the State reserving the right to fix a different rental on each fifth anniversary of the Tease.

BASIS FOR CONSIDERATION:

\$359.60 minimum rental for the powerline and telephone line easements and lecents per diameter inch per lineal foot of water-line.

PREREQUISITE TERMS, FEES AND EXPENSES: Filing fee has been received.

First year's rental in the amount of \$359.60 has been deposited with the Division,

Code 2907(a) which exempts an existing structure or facility that is in an acceptable state of repair and there is no evidence of record to show injury to adjacent property, shoreline erosion, or other types of environmental degradation.
- 2. This project is situated on State land identified as possessing significant

environmental values pursuant to Public Resources Code 6370.1, and is classified in a use category, Class B which authorizes Limited Use.

Staff review indicates that there will be no significant effect upon the identified environmental values. This is an existing facility for which no adverse comments have been received.

- AUTHORIZE ISSUANCE TO THE ANACONDA COMPANY OF A 15-YEAR REPLACEMENT OF RIGHT-OR-WAY DEASE PRO 4627.2 FROM MAY 9, 1977; WITH LESSEE'S OPTION TO RENEW FOR ONE SUCCESSIVE PERIOD OF 10 YEARS; IN CONSIDERATION OF ANNUAL RENT IN THE AMOUNT OF \$359.60 WITH THE STATE RESERVING THE RIGHT TO FIX A DIFFERENT RENTAL ON EACH FIFTH ANNIVER-SARY OF THE LEASE; PROVISION OF A \$3,000 SURETY BOND; PROVISION OF FUBLIC LIABILITY INSURANCE FOR BODILY INJURY AND PROPERTY DAMAGE FOR A COMBINED SINGLE LIMIT IN THE AMOUNT OF \$150,000; FOR THE OPERATION AND MAINTENANCE OF EXISTING UTILITY LINES CONSISTING OF A 4-INCH WATER PIPELINE, AN ELECTRIC POWER LINE AND A TELEPHONE LINE ON THE LAND DESCRIBED ON EXHIBIT "A" ATTACHED AND BY REFERENCE MADE A PART HEREOF.
