APPROVAL OF THE EMERGENCY SALE
OF INSECT DAMAGED TIMBER

The Executive Officer's report at the April 1978 meeting informed the Commission of a bark beetle attack that has killed 40 MBF Ponderosa Pine sawtimber on State school land about 15 miles southeast of Lakeport. The infestation is a threat to surrounding timber, and the damaged timber should be salvaged as soon as possible.

The staff solicited bids from timber operators in the Lakeport area and received 1 bid totaling \$1,000. This is considered to be a reasonable price because of the advanced stage of decay in some of the trees and because the purchaser must develop access to the parcel.

OTHER PERTINENT INFORMATION:

1. An EIR is not required. This project is an emergency action to prevent or mitigate loss through the salvage of insect-killed timber.
2. This project is on school land not identified as possessing significant environmental values. A staff review of available environmental information indicates no reason to identify the parcel as having such values at this time.

IT IS RECOMMENDED THAT THE COMMISSION:

1. DETERMINE THAT AN EIR HAS NOT BEEN PREPARED FOR THIS ACTIVITY AS SUCH REPORT IS NOT REQUIRED UNDER THE PROVISIONS OF P.R.C. 21172, 14 CAL. ADM. CODE 15071 AND 2 CAL. ADM. CODE 2905 (a).
2. ACCEPT THE BID IN THE AMOUNT OF \$1,000 AND AUTHORIZE THE STAFF TO ENTER INTO A TIMBER SALE AGREEMENT WITH RON BORGES LOGGING FOR THE SALE OF 40 MBF BEETLE-KILLED TIMBER IN THE SE $\frac{1}{4}$ SW $\frac{1}{4}$, SECTION 10, T12N R8W, MDM, LAKE COUNTY, UPON PAYMENT IN FULL OF THE BID PRICE.
