QUITCLAIM OF PERMITS TO PROSPECT FOR
GEOTHERMAL RESOURCES, PRC 4928.1 AND
PRC 4929.1, MODOC COUNTY

- PERMITTEE: Getty Oil Company

- LOCATIONS: PRC 4928.1 - Upper Alkali Lake, Modoc County.
 PRC 4929.1 - Middle Alkali Lake, Modoc County.
- ACREAGE: PRC 4928.1 - 5,427 acres.
 PRC 4929.1 - 4,430 acres.
- DATES OF ISSUANCE:
 PRC 4928.1 - June 27, 1974.
 PRC 4929.1 - June 27, 1974.
- REASON FOR QUITCLAIM:
 Getty Oil has conducted geophysical surveys
 which support the presence of thermal
 anomalies. Nevertheless, neither of the
 2 wells drilled in the Valley by Gulf Mineral
 Resources Company encountered commercially
 producibile geothermal fluids. Getty Oil
 had hoped to attract investors of high
 risk capital for the drilling of further
 wells in the area. However, since this
 did not materialize, Getty feels that
 additional exploration is unwarranted and
 has submitted quitclaims for the 2 prospecting
 permits.

 a. Quitclaims submitted by permittee,
 dated June 5, 1978.
 b. Compliance with terms and conditions
 of permits through June 15, 1978.
