AREA, TYPE LAND AND LOCATION:
A 0.029 acre strip (10' x 125') of tide
and submerged land in the bed of Sevenmile
Slough between Brannan Island and Twitchell
Island, Sacramento County.

LAND USE: Placement of a telephone cable on an existing
overhead power pole line structure.

TERM OF PROPOSED LEASE:
Initial period: Continuous use plus 1
year from December 1,
1978.

CONSIDERATION: Exempt pursuant to Section 7901, of the
Public Utilities Code.

PREREQUISITE TERMS, FEES AND EXPENSES:
Applicant is permittee of upland.

Filing fee and processing costs have been
received.

Gas and Electric Company's (PG&E) overhead power pole line. Installation will be done pursuant to a joint pole agreement between applicant and PG&E. The existing PG&E power line is covered by Lease PRC 534.1.

3. This project is exempt from CEQA because it involves the installation of small new equipment and facilities to an existing structure.

Authority: 14 Cal. Adm. Code, Section 15103, Class 3, New Construction of small structure.

4. This project is situated on State land identified as possessing significant environmental values pursuant to P.R.C. 6370.1, and is classified in a use category, Class B, which authorizes Limited Use.

Staff has coordinated this project with those agencies and organizations who nominated the site as containing significant environmental values. They have found this project to be compatible with their nomination.
