INFORMATIVE CALENDAR ITEM  
DREDGING PERMIT

In accordance with the Commission's delegation of authority to the Executive Officer for the issuance of dredging permits of 10,000 cubic yards or less, Calendar and Minute Item No. 32, February 24, 1977, permission was granted to perform project-related dredging on State-owned lands to the following party:

Meyer's Marina - Paul K. Meyer, Owner  
P. O. Box 2261  
Bakersfield, California 93303

The permit provides for excavation of a maximum of 500 cubic yards of material from an area of granted State-owned tide and submerged lands with minerals reserved to the State, in Morro Bay, at Meyer's Marina. Material will be spoiled at a private upland land fill; a royalty of \$0.25 per cubic yard to be paid for material placed upon private property, used to private or commercial benefit, or otherwise lost to future State benefit. The permit will be effective from April 1, 1979 through March 31, 1980.

In compliance with said delegation of authority, it has been determined that the following conditions have been met:

1. The proposed project is categorically exempt from the requirements of CEQA.
2. The issuance of the permit and the resultant project will have no significant adverse effect on the environment or the environmental characteristics identified pursuant to Section 6370.1 et seq., of the P.R.C.
3. The dredging amount will not exceed 10,000 cubic yards.
4. A charge per cubic yard will be assessed for spoils material that is deposited on private property or otherwise lost to future State benefit.
5. Approval of the project will be contingent upon approval by all pertinent State, Federal and local agencies.

EXHIBIT "A"

LAND DESCRIPTION

W 22067

A parcel of tide and submerged land in the bed of Morro Bay within the City of Morro Bay, County of San Luis Obispo, State of California, being Lease Site No. 37-W, and a portion of lands granted to the County of San Luis Obispo by Chapter 1076, Statutes of 1947 of the State of California, more particularly described as follows:

BEGINNING at Station No. 38 on the grant line shown on map entitled "Grant to County of San Luis Obispo" dated September 1957, filed in Book 1 of Miscellaneous Maps, page 2, Records of said County, thence along said grant line, the following six courses:

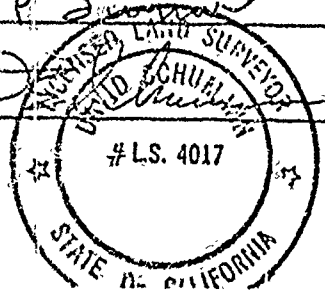
1. S. 43° 49' 51" E 69.31 feet to Station No. 37 on said grant line;
2. N. 89° 38' W 78.91 feet;
3. N. 52° 13' 28" W 59.90 feet;
4. N. 38° 38' 02" E 50 feet to a point which bears N. 88° 16' 06" W 13.71 feet along the westerly prolongation of the northerly line of Lot 8 of Block 1 of Morro Rock Park from its intersection with the portion of said grant line lying between Stations No. 38 and 39 thereon (the map of said Morro Rock Park is recorded in Book 3 of Maps at page 36, Records of said County);
5. S. 88° 16' 06" E 13.71 feet along said prolongation of said lot line to its intersection with said grant line;
6. thence along said grant line S 52° 13' E 42.19 feet, more or less, to Station No. 38 and the point of beginning.

EXCEPTING THEREFR, any portions lying landward of the ordinary high water mark of Morro Bay.

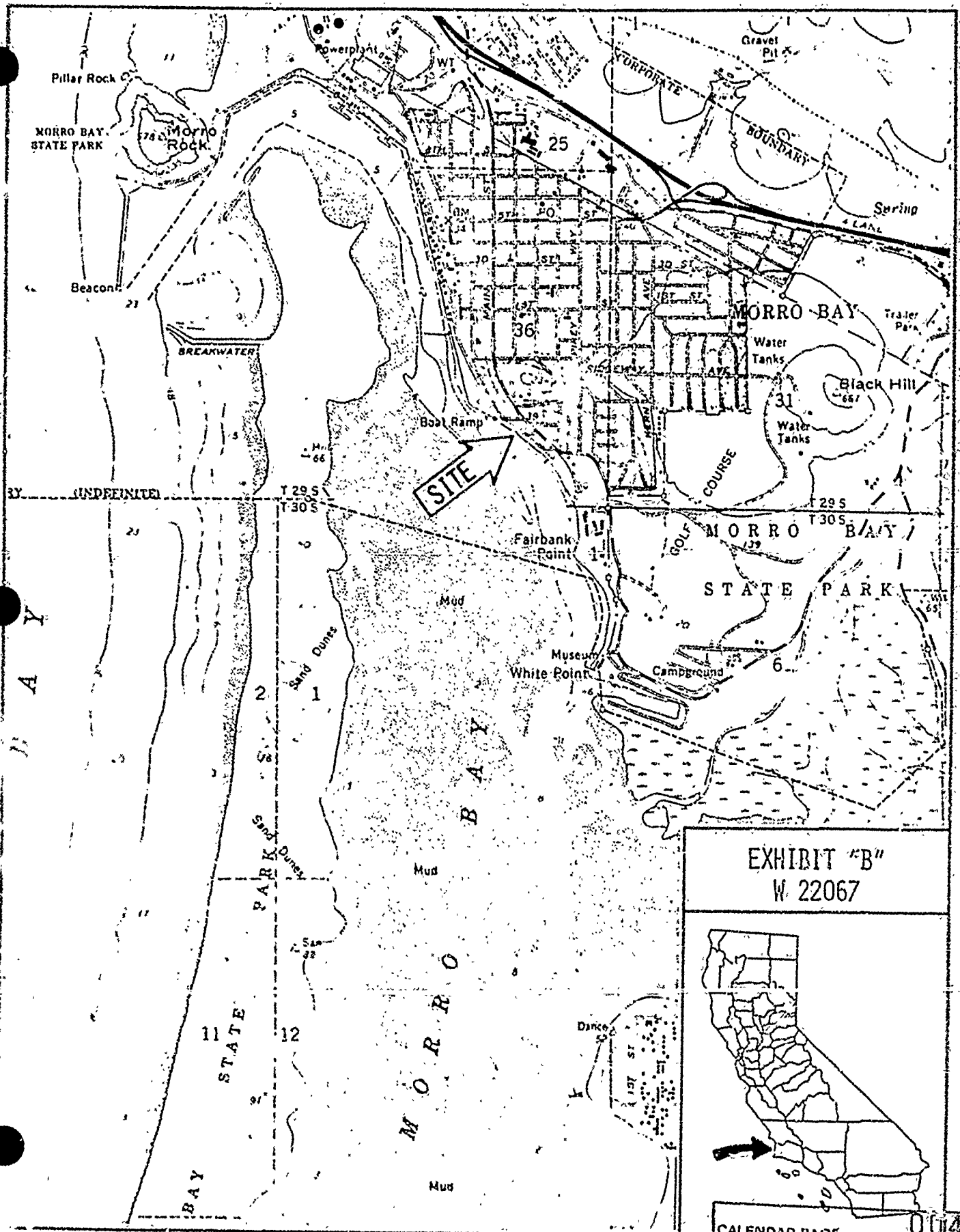
