AREA, TYPE I AND AND LOCATION:

Two strips of tidelands in the Pacific

Ocean along Mattole Road near Cape Mendocino,

Humboldt County.

LAND USE:

Construction and maintenance of a rock

toe seawall.

TERMS OF PROPOSED PERMIT:

Initial period:

49 years from May 1, 1979.

CONSIDERATION:

The public use and benefit, with the State reserving right at any time to set a monetary rental if the Commission finds such action

to be in the State's best interest.

PREREQUISITE TERMS, FEES AND EXPENSES:

Applicant is permittee of upland.

Processing costs have been received.

OTHER PERTINENT INFORMATION:

- The annual rental value of the site is estimated to be \$800.
- The entire project as proposed by the County involves reconstruction and protection of 2 sections of Mattole Road. The sections of roadway involved have been the subject of ongoing erosion from wave action for many years. The most severe damage occurred during the January 1978 storms.
- As a result of the storm damage, Governor Brown has declared this area of Humboldt County a major disaster area so that

it would qualify for emergency funding. The rederal Highway Administration has concurred with the Governor's proclamation and made available emergency funds for the reconstruction of the roadway.

- 4. The county, in order to prevent further erosion to Mattole Road, proposes to construct a rock toe seawall along these 2 sections of the roadway. There are 3 Public Access Corridors ("D", "E", and "F"), which were acquired by easement deed to the State as settlement of the Sierra Club v. Vanone Case, within the proposed seawall project.
- The county has agreed to provide public ·\$. access within the project area. In order to accomplish this the County has proposed to relocate public access corridors to more accessible locations and establish trails to the beach within the new corridors. Corridor "D" has been shifted north + 250' from the existing corridor to a point where the seawall will be 2 feet in height. Corridor "E" has been shifted south + 2001 to an existing trail. Corridor "F" has been shifted north + 200' feet from the existing corridor to a point beyond the seawall. The county has also agreed to construct and maintain turn-outs at Public Access Corridors "D", "E" and "F". The county shall accept liability within the public access corridors.
- 6. This project is consistent with Article 6.5 because it will protect the shoreline from erosion and provide public access.
- 7. This project is exempt from CEQA because it will restore and protect facilities damaged as a result of a disaster in a disaster stricken area in which a State of Emergency has been proclaimed by the Govenor.

8. This project is situated on State land identified as possessing significant environmental values pursuant to P.R.C. 6370.1, and is classified in a use category, Class B, which authorizes Limited Use.

Staff has coordinated this project with those agencies and organizations who nominated the site as containing significant environmental values. They have found this project to be compatible with their nomination.
