APPROVAL OF THE SEVENTH MODIFICATION OF THE 1978-1979
 PLAN OF DEVELOPMENT AND OPERATIONS AND BUDGET,
 LONG BEACH UNIT, WILMINGTON OIL FIELD, LOS ANGELES COUNTY

The City of Long Beach has requested approval of the Seventh Modification of the Plan of Development and Operations and Budget, Long Beach Unit, July 1, 1978, through June 30, 1979. This Modification transfers a total of \$557,000 within the existing Budget to provide funding to (1) pay the second installment of Los Angeles County personal property taxes, (2) purchase a diesel tractor and vacuum tank trailer, and (3) purchase a replacement forklift. Necessary funds will be provided by transfer from Ranger Zone development drilling funds and other tax related Budget Items where surplus funds exist.

The Seventh Modification will effect the following transfers within the 1978-1979 Budget, while the total budget, \$84,471,000, remains unchanged:
