ACCEPTANCE OF A QUITCLAIM DEED AND
TERMINATION OF AN INDUSTRIAL LEASE

BACKGROUND:

On October 24, 1951, the Commission approved Industrial Right-of-Way Lease PRC 660.1 with an initial period of 15 years from December 16, 1951, with renewal options of 2 successive periods of 10 years each to Standard Oil Company of California. The facilities covered by the original lease included a wharf and concrete pier which supports a salt-water intake pipeline.

In July 1972, the Commission renewed and amended the lease for 10 years beginning December 16, 1966. The delay in approving the renewal resulted from a disagreement between the parties as to rental. Also during that period of time the wharf had been removed and only the pier and pipeline remained.

In October 1976, the Commission authorized the assignment of this and numerous other leases with Standard Oil Company of California to a wholly-owned subsidiary corporation, Chevron USA, Inc.

In December 1976, the Commission approved renewing this lease for 10 additional years beginning December 16, 1976.

CURRENT SITUATION:

The staff was informed by the lessee in March 1978, that they intended to remove the salt-water intake line and supporting pier and terminate the lease. Staff reviewed and approved the lessee's plan for removal. Lease quitclaim deeds were also sent to the lessee for execution upon completing the work. In March 1979, the staff received a report covering the completed removal operation. This report was again reviewed by our engineering staff and found to be acceptable.

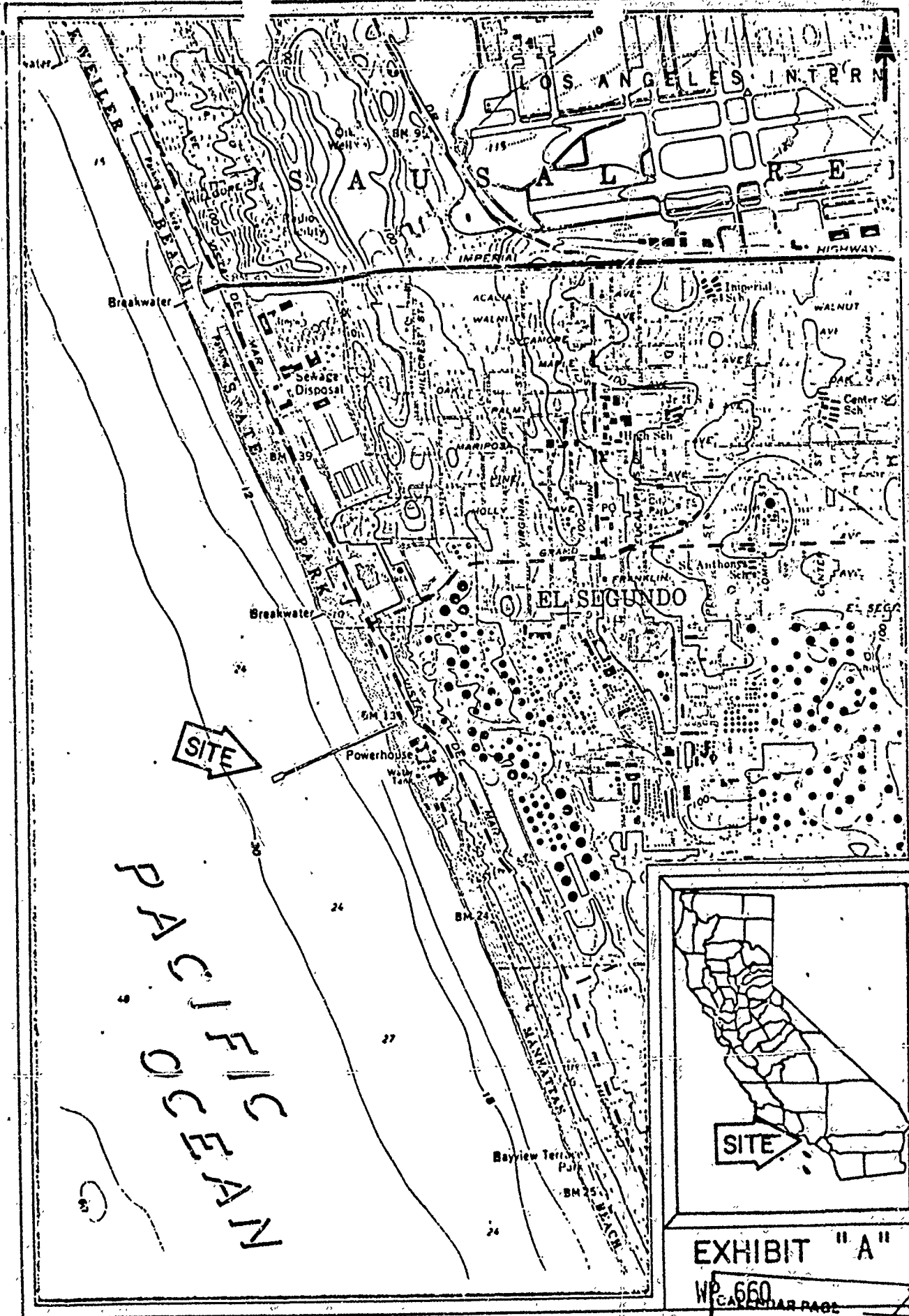

PACIFIC OCEAN

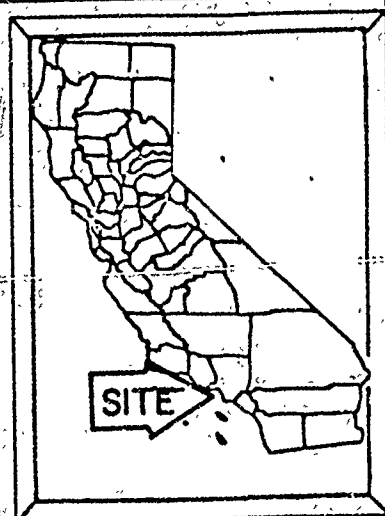
