24. ISSUANCE OF STATE PATENT. SU 6296

ISSUANCE OF STATE PATENT

The State acquired title to the NE $\frac{1}{4}$  NE $\frac{1}{4}$  of Section 17, T36N, R--9-E--7, R 8 E., MDM, containing 40 acres in Lassen County by Lieu Land Clear List No. 3, Susanville Land District, approved January 3, 1878. The original applicant (SU 743) on whose behalf the selection was made failed to comply with the requirements for payments of principal and interest under Title 8 of the Political Code and his partially paid Certificate of Purchase was annulled by decree of foreclosure by the Lassen County Superior Court on December 21, 1881. All interest in the land thereby reverting to the State Surveyor General. A second application (SU 2637) was filed on May 17, 1889 with a Certificate of Purchase being issued on January 4, 1890. The interest of the holder of that Certificate of Purchase was sold to the State for non-payment of taxes on March 13, 1897, the entire interest again reverting to the State Surveyor General.

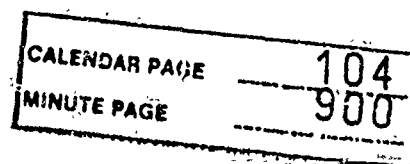
On June 10, 1924, Heber J. Kemper bid \$80, being \$2 per acre for said 40 acre parcel at public auction, held pursuant to the provision of Chapter 207, Statutes of 1919, at the Lassen County Courthouse in Susanville. The purchase price was paid in full on the date of auction and fully paid Certificate of Purchase No. 16032, was issued on June 17, 1924. The Kemper interest was sold for delinquent taxes on June 29, 1927 and reverted to the State of California on June 30, 1932.

The State Controller authorized sale of the parcel by auction and was sold on June 14, 1940 to the predecessor in interest of the present claimant.

The present claimant of the subject parcel, John B. Crook, has executed affidavit Form 64.9 made in accordance with the provisions of Section 7729 of the P.R.C. as amended by Chapter 243, Statutes of California, 1959, in lieu of surrendering the certificate of purchase. He has also submitted required proof of his interest in the land and his right to a patent therefore.

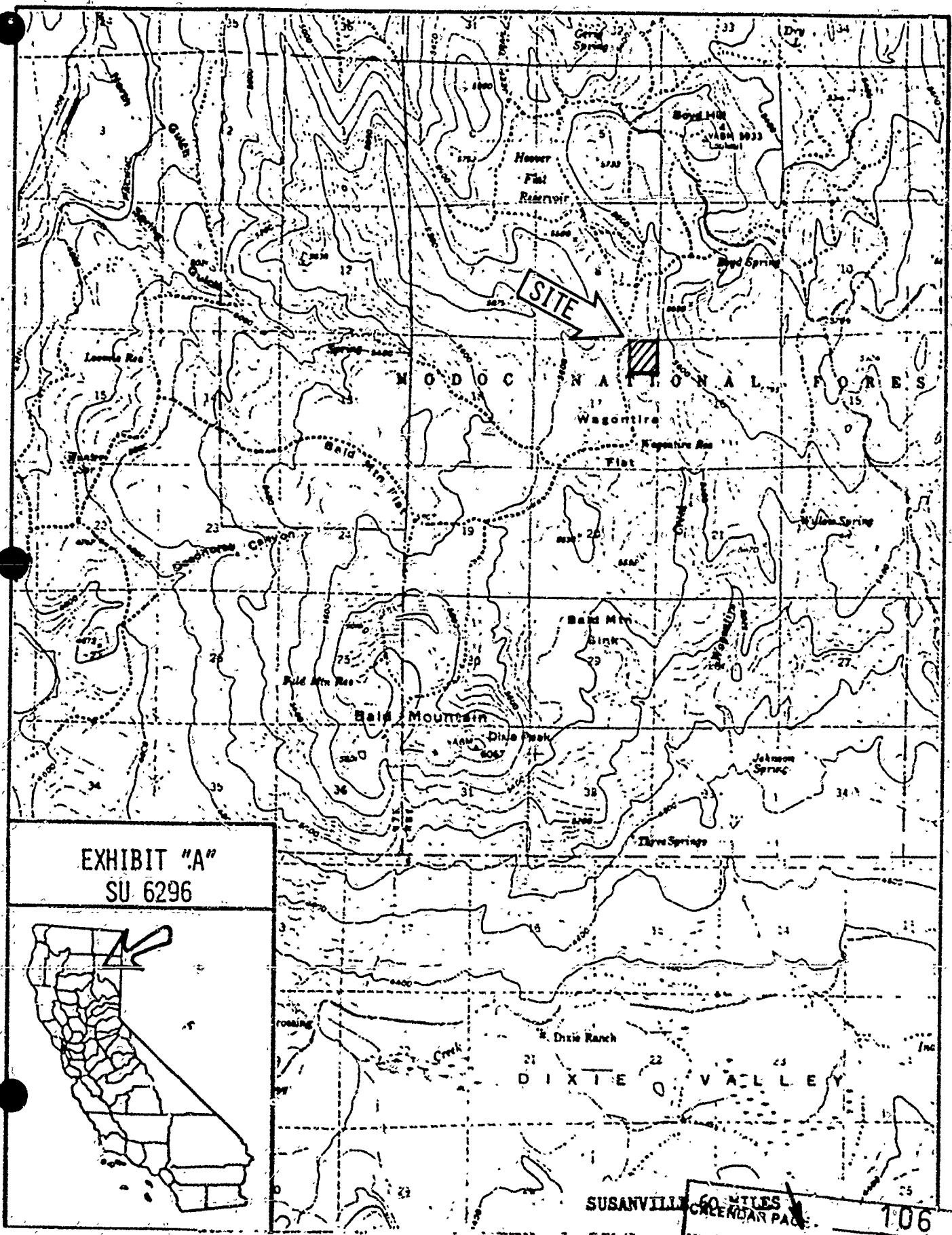
