AMENDMENT OF LEASE PRC 5438.1

APPLICANT: Pacific Gas and Electric Company  
245 Mission Street  
San Francisco, California 94106

AREA, TYPE LAND AND LOCATION:  
Approximately 0.16 acres in the bed of  
Lindsey Slough, Solano County.

LAND USE: Pipeline for transport of natural and synthetic  
gas.

TERMS OF EXISTING LEASE:

Initial period: 20-years from January 1,  
1978.

Renewal options: 2 successive periods  
of 10-years each.

Public liability insurance: combined single  
limit coverage of \$1,000,000.

Consideration: Volumetric rental pursuant  
to 2 Cal. Adm. Code 2005  
and 2006 with a minimum  
annual rental of \$15,000  
5-year review.

TERMS OF PROPOSED AMENDMENT:

Add new parcel; no change in other lease  
terms.

STATUTORY AND OTHER REFERENCES:

A. P.R.C.: Div. 6, Parts 1 & 2.

B. Cal. Adm. Code: Title 2, Div. 3.

OTHER PERTINENT INFORMATION:

1. At its meeting on January 26, 1978  
(Minute Item No. 24.) the Commission  
authorized issuance of a master gas  
pipeline lease to P.G.&E. covering  
their then existing 89 State lands  
leases. P.G.&E. has now applied to

the Commission for an amendment to the lease to add a new parcel which will connect McCullough Oil and Gas Corporation's Hasting's Ranch No. 1-22 gas well to P.G.&E.'s existing system, via a new 8-inch line.

Inasmuch as the existing master gas line lease includes a volumetric rental that applies to all gas passing through P.G.&E.'s gas pipeline system, an adjustment in rental is not required. All other terms of the existing lease will remain in effect.

2. This project is exempt from CEQA because it involves a minor alteration to land (minor trenching and backfilling).

Authority: 14 Cal. Adm. Code Section 15104(f).

3. This project is situated on State land identified as possessing significant environmental values pursuant to P.R.C. 6370.1, and is classified in a use category, Class B, which authorizes Limited Use.

Staff has coordinated this project with those agencies and organizations who nominated the site as containing significant environmental values. They have found this project to be compatible with their nomination.

FURTHER APPROVALS REQUIRED:

Local, United States Army Corps of Engineers.

2. FIND THAT GRANTING OF THE LEASE WILL HAVE NO SIGNIFICANT EFFECT UPON ENVIRONMENTAL CHARACTERISTICS IDENTIFIED PURSUANT TO SECTION 6370.1, OF THE P.R.C.
3. AUTHORIZE ISSUANCE TO PACIFIC GAS AND ELECTRIC COMPANY AMENDMENT TO LEASE PRC 5438.1 EFFECTIVE AUGUST 1, 1979 WHICH ADDS A NEW PARCEL TO SAID LEASE AS DESCRIBED ON EXHIBIT "A" ATTACHED AND BY REFERENCE MADE A PART HEREOF, FOR THE CONSTRUCTION AND MAINTENANCE OF A NEW 8-INCH GAS PIPELINE; PROVIDED THAT ALL OTHER TERMS AND CONDITIONS OF SUCH LEASE SHALL REMAIN IN FULL FORCE AND EFFECT.



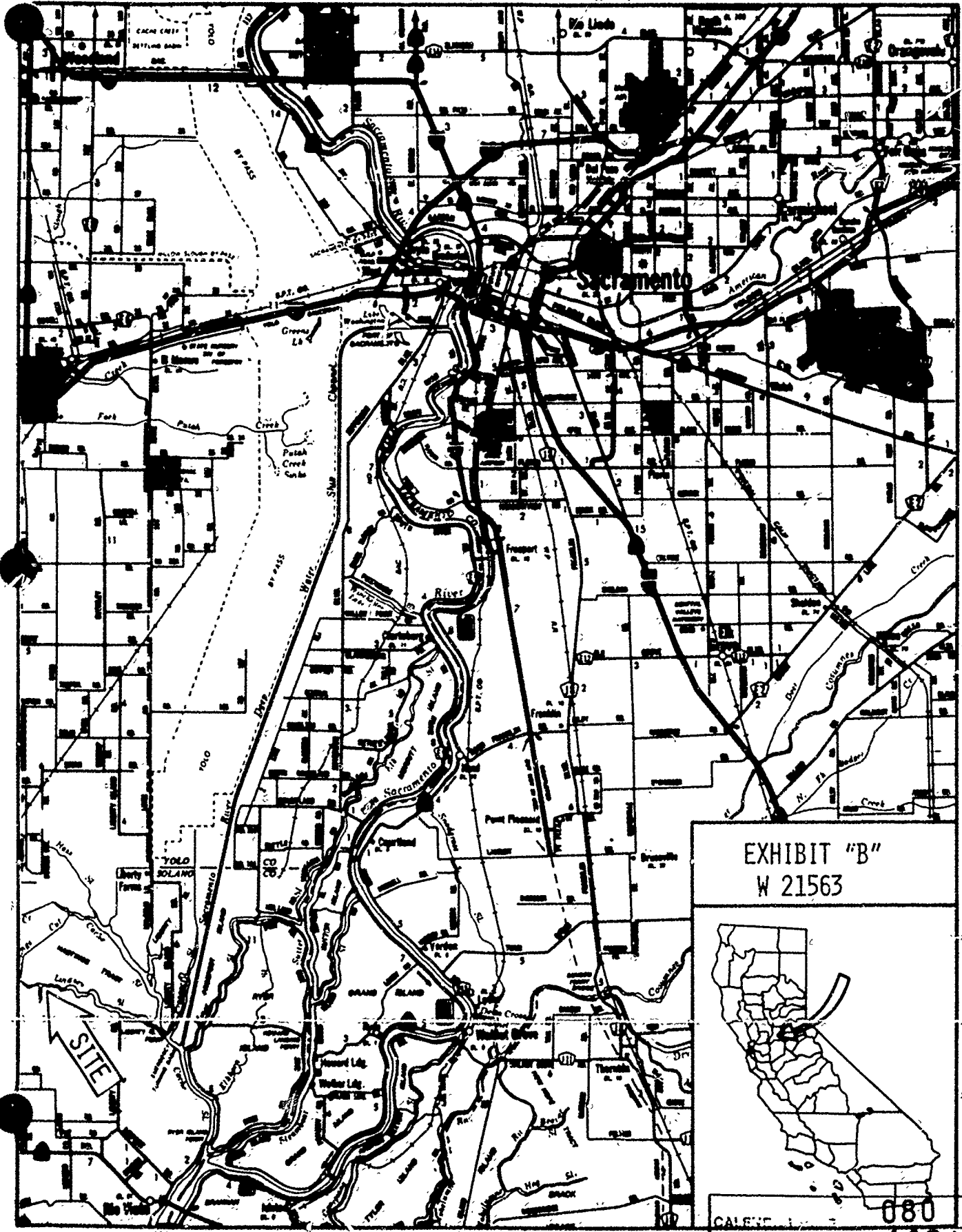
